### NEW POSTER IS OUT

1916 Rose Festival Design Advertises Scenery of Famous Columbia River



Portland's 1916 Rose Festival poster is the first publicity, national in scope, to go forth advertising the beauties of the Columbia river. The festival will be held June 7, 8 and 9. Opening day will witness the national dedication of the Columbia river highway. The poster carries the slogan "For You a Rose in Portland Grows." The poster was donated by Fred G. Cooper, former Oregon boy, now famous as an artist. The design will soon hang in transportation offices all over the United States.

### JOBBER USE AUCTION

J. Pratt Carroll, jobber of New York, who has opposed auction selling of Florida oranges until this year, sold cars at auction for the first time. Curran Robertson and Company is another firm in New York that but recently has given up the fight against the auction as far as Florida fruits are concerned.

Steinhardt and Kelly, E. P. Loomis and Co., John Nix and practically all of the jobbing firms that operate in the Northwest have been patrons of the auction for oranges, pears, grapes and many other fruits for a number of years. This year, Steinhardt and Kelly paid cash for a number of cars of Florida fruits and sold them at auction. Mr. Steinhardt, just before Christmas, introduced a new package of oranges to auction buyers. It was a small package that could be carried home, weighing about twenty pounds.

### Burrowers--Beware!

Gophers and prairie dogs are the bane of western farmers, while in the east woodchucks are the type of burrowing animals that cause the tillers of the soil to forget some of the things the dominie tells them on Sundays. Don Leonardo Ruiz, a California rancher, says "dynamite is the proper medicine to give ground squirrels, gophers, prairie dogs, etc."

Take an inch and a half or two inches of dynamite. Put it in a bit of cloth or several thicknesses of paper to form a small round cartridge. Tie the cloth or paper firmly about one end of a piece of fuse twelve or fourteen inches long, but do not use a cap.

Insert one of these charges well into the mouth of every hole and pack loose dirt around the fuse, leaving enough of the end outside to light easily. Light the fuse and go on to the next hole. There will be no explosion.

There being no cap or other detonator, the dynamite will simply burn, filling the hole with dense, poisonous fumes that will almost instantly stifle and then kill every living thing inside.

#### Geranium Oil.

Geranium oil is largely used in perfumery and is known as rose geranium owing to the common practice of adding rose petals to the plants before distillation.

## DILLON WINS ENDORSEMENT

### New York Growers Meet in Annual Convention

### JOBBER PLAYED OUT

New York--"The present game of the speculating jobber is about played out," says John J. Dillon, Director of the Department of Markets for New York, "and with better organization among the apple growers present marketing methods will soon be ancient history. The growers are interested in getting the highest average price for their crop, while the speculator has been interested in holding all the fruit out of the market until his was sold at a profit to himself.

The grower is the great sufferer when the price is held above that at which the consumer is willing to buy. When the demand is choked off, the grower with great numbers of cars unsold is the loser. It is better for the grower to have the price be a little low than too high. Low priced fruit results in a greater distribution, which in turn increases the demand and sends the price up above what the private sale system makes possible."

Flushed by the unanimous endorsement of the New York Apple Growers' Association in their convention recently held at Rochester, Mr. Dillon is going ahead with his plan to gain increased support from the legislature so that his department can be capable of insuring that the auction receives regular supplies of first class barrel apples during the coming season.

It is interesting to read a paragraph concerning the meeting of apple growers from the Packer, which along with the large jobbing houses has been one of the chief antagonists of the Department of Markets. It reads, "Frank M. Bradley, of Barker, president of the association, was there to jam down the throats of the convention a resolution endorsing Commissioner Dillon's auction system. Mr. Bradley was assisted by E. W. Mitchell of Kinderhook."

Later in the same article, mention is

made that the growers not only passed the resolution unanimously but rejected Mr. Bradley president by the same sized vote; which is taken as an inference that perhaps Mr. Bradley did not have to do much cramming to persuade the growers that the auction of the Department of Markets should be supported.

The American Agriculturist reads: "Two factors are essential in any enterprise. First, that the plan or system be correct; and secondly, that the man or men who manage it be capable. Experience of years in foreign countries and our own has shown that the auction method, properly carried on, is sound. But New York has failed, not because of a wrong system, but because of the man at the head of its foods and markets department."

In the news columns of the same issue an account of the discussion of the auction at the annual meeting of the New York Fruit Growers' Association reads, "The growers feel that auction sales properly conducted are a good thing, and if extended along non-partisan lines could do much to boost prices to the grower. Competition among buyers at the auction sales is pointed out as a chief factor in stimulating independent buying."

Ex-Senator Lupton, a large grower at Winchester, Virginia, spoke at the convention concerning an attempt to auction apples in his state. He said, "The auction system is extremely interesting to us Virginia growers. I have had some experience with auction sales. Fifteen or twenty of us growers around Winchester signed up an agreement to sell our fruit at auction. The day before the auction we met and fixed our price at \$3.50 per barrel, agreeing to sell at that figure. At the auction the first block put up was 6,000 barrels, and a prominent New York dealer made a bid of \$2.50 per barrel for the fruit.

"The owner of the apples refused to sell and took down the fruit. This threw the auction sale into confusion. The buyer was disappointed and the auction sale was abandoned."
