The Tax Collections

Taxes are coming in rather slowly owing to the change in the law governing the interest and penalty on unpaid amounts. Under the new law if the first half is paid on or before April 5 the taxpayer has until Oct. 5 to pay second half without interest on either part and if nothing is paid on April 5 interest on first half only will be charged until Oct. 5. After Oct. 5 interest will be charged also on second half. The penalty on either part does not attach until November 5.

The total amount on the rolls is \$778,778., of which \$147,250 has been paid up to March 23; this is about \$45,000 less than for some period last year.

It is the consensus of opinion that if the 5% rebate was allowed as in former years the bulk of the taxes would be paid by April 5.

APPLE TRADE IS HOPEFUL

Despite Increased Supply System Will Win

FOREIGN SALES GROW

"There are many hopeful signs in the box-apple industry despite the rapid increase in production," says Arthur M. Geary, who returned recently to his home in Portland from three months spent in the Eastern markets.

"The general prosperity throughout the East as well as in most other parts of the country is giving more buying ability to the consumers and enabling them to be more particular about the kind of apples that they eat.

Packs Are Standard.

"The apple packs from the Oregon and Washington districts have been uniformly good as compared with the previous year. However, the trade throughout the east is not waxing enthusiastic about the packs, as they ex-

pect the Northwestern box-apple to prove true to brand, just as they expect to find anything from a piece of stove pipe to potatoes in the barrels shipped from some of the Eastern districts.

"During most of this shipping season, the ability to get space alone has limited the size of shipments to the auctions in London, Liverpool and Glasgow and to the markets in Denmark, and Norway and Sweden.

"The South American market has but barely been scratched in developing a demand for apples from the United States. The freight from New York to Rio de Janeiro, Buenos Aires, and Montevideo is about \$1.00 per box; so when the freight of 50 to 60 cents a box from the Pacific Coast to New York is added, the total is such that it pays the South Americans only to buy the very best grades.

"When there are lines of ships running from the Pacific Coast to the east shores of South America, it will be possible for the shippers to save 40 or 50 cents a box by shipping direct to South America.

"Until the tariff was reduced upon meat imported to this country, it was impossible to send apples direct from New York to South America because of lack of refrigerated space. The fruit was shipped to Liverpool and there was transhipped to South America. The

North Yakima Cider Has Strong Kick Say Police

North Yakima, Wash., March 27—Charged with selling cider containing alcohol in violation of the state prohibition law, C. W. Smith, proprietor of a soft drink establishment in this city, has been arrested by the police. The police say analysis of cider purchased at Smith's place shows from 3 1/2 to 6% alcohol, and they express the belief that some of the alcohol content sold by druggists in this city "for medicinal purposes" has been added to the cider.

Big Stock of Liquor Discovered in Raid.

Centralia, Wash., March 29—As the result of a raid shortly before noon yesterday by Chief of Police McGrail and Police Judge A. F. Giere, on a local residence, the office of the judge resembles a saloon and Nettie Rhoads is under arrest on charges of violating and violating the liquor law. The woman has been released under \$35 bonds pending her hearing in police court in about 10 days. The liquor confiscated by the officers includes 30 quarts of beer, one quart of champagne, a five-gallon cask of brandy, a quart of whiskey and five quarts of wine.
