Portland, April 4—Municipal Judge Langguth construed the prohibition law this morning in such a manner that while the city ordinance prohibiting the drinking of liquor in a restaurant may have been superseded by the state law, yet the latter prohibits the drinking of liquor in restaurants, dance halls or other public gatherings.

So wide is Judge Langguth's interpretation of the prohibition law that it will even affect the drinking of liquor at picnics. Judge Langguth said that the law was elastic and would cover almost any case of the sort that the state might bring.
