Paper Mills to Use New Woods

As the result of studies which have been made at the Forest Products Laboratory on methods of handling wood chips suitable for paper pulp, it is announced that Wisconsin paper companies are now negotiating with the railroads for shipment to their factories of experimental trainloads of chips of western woods adapted to paper making.

Previous investigations by the Forest Service have demonstrated that good grades of paper can be made from a number of western woods. The experts now estimate that some of these woods when cut into chips and dried and baled, can be delivered to the mills in Wisconsin at a very small advance over the cost of chips made from local timber. If a favorable freight rate can be obtained, they say, the great quantity of pulpwood on the National Forests should prove to be a considerable factor in supplying favorable located paper mills with the necessary raw material. In Wisconsin alone, it is stated, there is an annual market for over 300,000 cords of pulpwood.

Villa Reported on Hearst Ranch

El Paso, Texas, Oct. 17—Francisco Villa is now on the Hearst ranch at Fabicora, according to statements of passengers arriving here today from Pearson, a station on the Mexico Northwestern railway below the American expeditionary base. Passengers from Parral say that Villa bands are moving northward and advices from Torreon report them heading northwest.

The value of the total mineral output of Alaska during the year is stated as \$32,854,223, as compared with \$19,065,666 for 1914.

Crescent Swept By Blaze

Lapine, Or., Oct. 18—A destructive fire is raging at Crescent since 10 o'clock this morning. The majority of the buildings in the town have been destroyed, and efforts are now being concentrated on saving the drugstore. A brisk wind makes the work difficult. The fire started in the Hotel Crescent from an unknown cause, presumably from an overheated chimney.

Lad Struck by Auto

Beaverton, Or., Oct. 17—Francis Parker, little son of F. E. Parker, a resident of this place, was run down by an automobile yesterday as he was playing in the road. The machine passed completely over him and it was feared for a while that he was seriously injured, but he is recovering nicely. Polk County Growers Harvest Their Peppermint.

Dallas, Or., Oct. 17—Farmers in this vicinity who planted peppermint last spring as an experiment began yesterday to harvest the crop, which will be much larger than expected for this first year. About 20 acres near this city were set out to plants last spring. The peppermint is now three and four feet high and is being cut with mowers after which it will be distilled at a local plant and the product shipped East. Next year a much larger acreage will be set to peppermint.
