These persons were John Doe and Richard Roe, and no two persons were more frequently referred to in legal documents. In every process of ejectment, instead of the real parties to the sult being named, John Doc, plaintiff, sued Richard Roe, defendant. Their names were also inserted in criminal proceedings. This fiction was introduced into English legal practice in the time of Edward III., in consequence, it was said, required the production of witnesses before every criminal trial, and henceforth John Doe and Richard Roe were inserted as the names of the alleged witness, a custom which was carried across the Atlantic to this country .-Indianapolis News.


