Big Return From Blue Ledge Ore.

The returns from the first car of ore shipped to the Tacoma smelter has been received and is an agreeable surprise to many of the people of this county. It had been predicted that returns would show a gross value of \$89, to \$80, per ton, but the returns show a gross value of \$103.50 per ton.

Manager Carnahan of the Blue Ledge mine stated Friday that the figures furnished him by the Tacoma smelter show that the ore ran 16 per cent copper, which at the market price of 30c per pound would amount to \$48.00 per ton. Gold and silver ran \$7.50 to the ton or \$103.50 gross return per ton. This makes the gross from the car of 31 tons shipped to Tacoma \$3,519.

Mining, smelting and freight charges are very reasonable; according to Mr. Carnahan, so that the net profit runs very high even though the ore must be hauled to Jacksonville from the mines by team and truck. The ore was run of mine, not hand picked.

128 Years since his first Inauguration
118 Years since his Death

Honors to Washington

ON Wednesday last the mortal part of Washington the great—the Father of His Country and the friend of man—was consigned to the tomb with solemn honors and funeral pomp.

This is the opening paragraph in the newspaper story of the burial of George Washington as told by the Ulster County Gazette, published at Kingston, N. Y., Jan. 4, 1800. Although the column rules of the newspaper are inverted, the story appears to have been only secondary in importance in the minds of the editors, as it is published on the third page and without any unusual display.

It is dated at Georgetown, Dec. 20, 1799, and bears the modest head "Washington Entombed." Genuine copies of the paper are rare and valuable, but it has been reprinted in facsimile many times.

The paper says:

"A multitude of persons assembled from miles around at Mount Vernon, the choice abode and last residence of the illustrious chief. There were the graves—the spacious avenues, the beautiful and sublime scenes, the noble mansion—but, alas, the august inhabitant was now no more! That great soul was gone. His mortal part was there indeed; but, ah, how affecting, how awful the spectacle of such worth and greatness, thus, to mortal eyes, fallen—yes, fallen, fallen!

"In the long and lofty portico, where oft the hero walked in all his glory, now lay the shrouded corpse. The countenance, still composed and serene, seemed to express the dignity of the spirit which lately dwelled in the lifeless form. There those who paid the last and honors to the benefactor of his country took an impressive—a farewell—view.

"On the ornament at the head of the coffin was inscribed 'Surge ad Judicium,' about the middle of the coffin, 'Gloria Deo,' and on the silver plate, 'General George Washington, departed this life on the 14th of December, 1799, Aet. 68.'

"Between 3 and 4 o'clock the sound of artillery from the vessel in the river firing minute guns awoke afresh our solemn sorrow—the corpse was removed—a band of music with mournful melody melted the soul into all the tenderness of woe.

"The procession was formed and moved on in the following order with arms reversed:

"Cavalry, infantry, guard, music and clergy.

"The general's horse with his saddle, holster and pistols.

"Colonels Simms, Ramsey, Payne, Gilpin, Marsteller and Little, pallbearers; corpse, mourners, Masonic brethren, citizens.

"When the procession had arrived at the bottom of the elevated lawn, on the banks of the Potomac, where the family vault is placed, the cavalry halted, the infantry marched toward the mound and formed their lines, the clergy, the Masonic brethren and the citizens descended to the vault, and the funeral service of the church was performed.

"The firing was repeated from the vessel in the river and the sounds echoed from the woods and hills around.

"Three general discharges by the infantry, the cavalry and eleven pieces of artillery, which lined the banks of the Potomac back of the vault, paid the last tribute to the entombed commander in chief of the armies of the United States and to the departed hero.

"The sun was now setting. Alas, the sun of glory was set forever! No, the name of Washington, the American president and general, will triumph over death! The undimmed brightness of his glory will illuminate the future ages!"
