Government Price Of Potatoes Displeases.

Yakima, Wash., March 11—Some other districts in Washington may have No. 1 potatoes to sell the government in 40-ton lots at \$17 a ton, but the indications are that few carloads will go from Yakima at that price. Government officials, who a short time ago were induced to hereafter accept offerings of 40-ton lots instead of a minimum of 500,000 pounds, in a letter to R. K. Tiffany, president of the Yakima Commercial club, suggest that an f. o. b. price at Yakima of \$17 per ton is about all the bidders should figure on, as Washington potatoes have been offered at about that figure. Enthusiasm on the part of the growers is lacking.
