Ordinance No. 1031

An Ordinance Submitting Amendments to Sections 5, 10, 15, 17, 26, 31, 32, of the Charter of the City of Jacksonville, Oregon, to conform to the requirements of Section 144 of Article II, Constitution of the State of Oregon, as to time of holding elections.

THE PEOPLE OF THE CITY OF JACKSONVILLE OREGON DO ORDAIN AS FOLLOWS:

That the following proposed Charter Amendments be submitted to a vote of the electors of the City of Jacksonville, for their approval or rejection, at a special election to be held in the City Hall in the City of Jacksonville, Oregon, on the 1st day of April 1918, between the hours of 12 o'clock M. and 7 o'clock P. M.

An Act to amend Sections 5, 10, 16, 17, 26, 31 and 32 of the Charter of The City of Jacksonville.

The people of the City of Jacksonville do ordain as follows: That Sections 5, 10, 16, 17, 26, 31 and 32, be and the same are hereby amended to read as follows:

Section 5. The Mayor and members of the City Council shall be elected and hold office for a term of two years, or until their successors shall have been elected and qualified: Provided, that at the general election held in 1918, there shall be elected two councilmen, each to hold office for the term of one year or until their successors are elected and qualified, and two councilmen, each to hold office for the term of two years, or until their successors are elected and qualified.

Section 10. It shall be the duty of the City Council, upon their election and qualification, and not later than the second Tuesday in January, following the general municipal election, to elect by ballot one city marshal and one street commissioner, who shall each hold office for the term of one year unless sooner removed by vote of the city council, in which event the city council shall immediately elect a successor to the officer so removed, to hold for the unexpired term or until removed by vote of the council.

Section 16. A general municipal election shall be held on the first Tuesday after the first Monday in November of each year, at which election the officers provided for by this charter shall be elected.

Section 17. Not less than 15 days prior to the time for holding the general municipal election as provided in Section 16, the city council shall, by resolution order said general municipal election, therein specifying the officers to be elected and the ballot titles of the measure or measures, if any, to be submitted to the voters, and shall by said resolution appoint three judges and two clerks to conduct said election and shall appoint the time and polling place therefor: Provided, that in the years that a general state election is held the municipal election shall be conducted by the officers of such general state election, for which service the county shall be reimbursed as provided by law.

Section 26. The judges and clerks at all municipal elections other than those conducted by the officers of the county and state elections shall each be paid \$250 for their services and the polls shall be opened at 12 o'clock M. and shall remain open until 7 o'clock P. M.

Section 31. The council shall on the second Tuesday of January following the date of each general election, take the oath of office and shall hold regular meetings at least once in each month, at such times as they shall fix by ordinance. Special meetings may be called at any time by the mayor, by written notice delivered to each member then within the city, at least three hours before the time specified for the proposed meeting, which notice shall specify the object and purpose of the meeting and no other business shall be transacted at any special meeting than that named in said notice. Personal appearance by any member of the council at any special meeting shall be deemed as to him, equivalent to due notice.

Section 32. The terms of all officers elected shall begin on the second Tuesday in January, or as soon thereafter as they shall duly qualify, but if an officer should fail to qualify within ten days from and after said day, then said office may by the council be declared vacant, and the council at the same meeting at which the office is declared vacant, shall proceed to fill the vacancy by election; and all vacancies from any cause, in any elective office shall be filled by the council by the election of some qualified elector of the city to said vacancy, who shall hold said office until the next general municipal election and until his successor is elected and qualified.

The following is the form in which the foregoing measure will appear upon the ballot: Special Election, City of Jacksonville April 1, 1918. Charter Amendments Submitted to the voters by the City Council. Mark X between the number and an-

swer voted for.

Million Cases of Pineapples. During last year Hawaii exported a million cases of cured pineapple, and 100,000 cases of the juice, and when it is understood that it takes a pineapple ten months to mature and that each plant bears only four pineapples in its lifetime of three years, Hawaii's exportation of the fruit makes a creditable showing.

Length of Lobsters. Whatever may be the excellent intent of the bill filed in the Massachusetts legislature reducing the length of lobsters that may be legally taken from 9 to 8 inches, the measure might well be entitled a bill to further the extermination of the lobster. The lobster is rapidly disappearing, partly, at any rate, because young and immature specimens are permitted by law to be caught. The present 9 inches in this state is shorter than the Maine law allows—and that is none too long.—Boston Post.
