The Southern Pacific hauled close to 5,000,000 pounds of cheese out of Tillamook in 1917 and the County collected over \$1,000,000. The industry is now so well established and conducted on such a sanitary and scientific basis that Tillamook cows work overtime working the international cheese record for 1918 is in sight.

Logger Killed in Camp.

Eugene, Or., March 18.—B. E. Sharp, aged 21 years and married, was killed by a falling tree in one of the logging camps of the Booth-Kelly Lumber company above Wendling on Saturday. The body was taken to Cottage Grove for burial.

Canadian Fisheries Had Record Year.

Owing to the greatly increased demand for fish and the higher prices prevailing, the total market value of Canadian fisheries for the last fiscal year constituted a record. It amounted to \$39,208,378, according to the annual report of the fisheries branch, issued recently. This was \$3,347,670 greater than the value for the previous year.

To the total value the sea fisheries contributed \$34,386,913, and the inland fisheries, \$4,822,365. The British Columbia catch headed the list, with a value of \$14,637,346, the figures for the rest being: Nova Scotia, \$10,002,902; New Brunswick, \$5,056,859; Quebec, \$2,961,624; Ontario, \$2,658,993; Manitoba, \$1,344,170; Saskatchewan, \$231,946; Alberta, \$144,317, and Yukon, \$90,210. As usual, the salmon catch was more valuable than any other, amounting to \$10,882,431. Lobsters were caught to the value of \$5,598,054; cod, \$5,440,964; herring, \$3,650,421, and halibut, \$2,263,573.—Fishing Gazette.

To The American People

We will continue to do our utmost, under Government direction, to increase our production and assist the Food Administration. We consider that the opportunity to co-operate whole-heartedly and to our fullest powers with this branch of the Government is our plain and most pressing duty.

The Trade Commission Attorney has, by false inference and misplaced emphasis, given to disconnected portions of the correspondence taken from our private files and read into the Record, a false and sinister meaning with the plain purpose of creating antagonistic public opinion.

The services of the packers of the United States are most urgently needed, and I regret exceedingly that we should at this time have to spend our efforts in defending ourselves against unfounded, unproved, and unfair assertions such as are being daily made public.

Piez, general manager of the emergency fleet corporation. He suggested the employment of a practical shipbuilder to have charge of enlarging some of the present Atlantic coast shipyards and to have the government take over construction at some of the plants.

Villa Forces at Work.

El Paso, Tex., March 18—Information was received here today from Teron, Mexico, stating that revolutionists had captured and occupied Durango City. No date or details were given in the meager notice received here. As Francisco Villa's main force has been campaigning in the state of Durango, it is believed here the reported capture of the state capital was made by this command. No confirmation of the report has yet been received here.
