Letter From Overseas

J. H. Beery Receives Letter From Son, Edwin, In France

The following is a copy of a letter received recently by J. H. Beery of this city, from his son, Edwin D., who is still on duty with the 319 Engineers, American Expeditionary Force, in France.

Dear Dad and Mother:-

I got back from my two weeks tour of France O.K. and you can bet I enjoyed myself being as it was the first time I had off for a year. I was in Paris twice, but didn't get to see as much of it as I would have liked to but to see that much would have taken me six months or more.

But at any rate I got to find out that Paris is all that one hears about her. You know that Paris has the greatest subway system in the world. I didn't get to go down and ride on it as they were on a strike. I didn't care much as there was plenty to see on top.

I went up to the battle front and saw quite a bit of that. I found Jim's grave. It was in that little hamlet you sent me the address of, about one and a quarter miles from Ste' Menchehold. That was all I could find out about it.

I got your letter telling about President Wilson's speech that he made Memorial Day, and would like to have heard it. I was in Rheims that day and went to the services the Americans and French held.

They can all talk about Verdun being shot up so bad, but I'll put in with 'em if it's any worse than Rheims. But as far as that goes, all of those towns are nothing but ruins.

I sent a vase from Rheims and also some little booklets from Paris; hoping you get them all right. Edward also sent a couple packages from here.

We have something for mother, that we will bring back with us, instead of mailing it. We won't be able to send you all something, so if we get a souvenir for mother, you will have to be satisfied with that.

Our company took over the railroad here in camp the other day and I happened to get a soft job. But something is bound to happen pretty soon. Never in my life before did I have a real snap that something didn't happen to spoil it.

I'm not going to say when I think we will be home, as I have already lied to you about it so many times; we were badly disappointed last December ourselves.

But anyway, we told you a long time ago to send us our firecrackers, so we could celebrate the Fourth in good shape, and they haven't come yet.

Well I have run out of paper, and am writing this in the job, so will have to stop for this time.

Some Recent Happenings In Various Parts of Oregon

Packing Plant to be Rebuilt.

Albany, Or., July 20.—Rapid progress is being made in the rebuilding of the big packing plant of the Nebergall company, which was burned recently. Some of the former walls are being utilized in reconstruction. The new plant will be a larger and a better one than the old.

Aviation School is Incorporated.

Salem, Or., July 19.—Articles of incorporation have been filed in Salem by the Hawthorne Auto Gas Tractor and Aviation school. The incorporators are G. E. Robinson, N. J. Robinson and Dan Powers. The capital stock is \$5000. It is the purpose of the corporation to deal in automobiles and conduct a general automobile school.

Horses May Be Eaten.

Salem, Or., July 20.—Favorable action by congress in furnishing legal inspection of horse meat may be the means of placing 30,000 range animals in eastern Oregon in the hands of dealers, according to Dr. W. H. Lytle, state veterinarian. These horses are in little demand, according to Dr. Lytle, and it is said the owners would be glad to dispose of them at almost any price.

The livestock situation was never better in Oregon than at the present time, according to Dr. Lytle, with sheep and hogs bringing the highest prices in history.

Little Boy Burns Home.

Hood River, Or., July 20.—Fire started by Victor Howell, 3-year-old son of Frank Howell, who was playing with matches, completely destroyed his parent's home Saturday. The child was cut off by the flames and was rescued with difficulty.

The house was owned by H. M. Morse, deputy engineer of Lane county, who lives in Eugene and who was formerly city water superintendent here.

Boy Fined for Killing Deer.

Eugene, Or., July 20. Tom Mitchell, 16-year-old boy of Earl, in the western part of Lane county, was arrested last week and fined \$25 by Justice R. E. Abbey for killing a deer, but the sentence was afterward suspended.

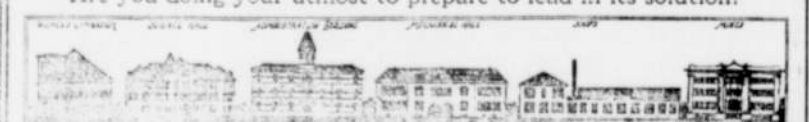
