**LOCAL SCHOOLS OPEN MONDAY.**  
**Jacksonville to Have Standard High School.**

The Jacksonville high school will open Monday morning with a standard four year high school. The corps of teachers have with almost no exception, been changed since last term. Mr. Godward, the principal, being the only one to remain from last term.

Miss Emma Spulak, the assistant principal, is a graduate of the University of Oregon, and well qualified for the place.

Professor Godward states that the courses will be along commercial lines, rather than the classic, French will be taught as several of the students have already made progress in that study. Miss Spulak has had training in Spanish and if any student desires to take up that language, it will likely be taught.

Professor Godward expects to arouse much interest in the school work this year. This will be the first time in years that the local high school has handled the entire course of four years.

An odd bit of the past turns up in a list of old publications soon to be sold at auction, namely, to give it its full, imposing title, "A Sermon Preached at White-Chapel, in the Presence of Many Honorable and Worshipful, the Adventurers and Planters for Virginia," and "Published for the Benefit and Use of the Colony, Planted, and to be Planted there and for the Advancement of their Christian Purpose." The Rev. William Symonds preached that sermon, notes the Christian Science Monitor, and described Virginia as a land "with the fruitfulness whereof England, our mistress, cannot compare, no, not when she is in her greatest pride." Yet he preached to rather a sorry congregation, says history, largely composed of immigrants who had failed at home through bad habits little calculated to help in a new country.

**Battle of the Giants.**

According to Brewer's "Historic Note Book," neither the battle of Waterloo nor the battle of Austerlitz was known as the "Battle of the Giants," but the battle of Marignano was so designated. This battle was fought on September 13, 1515, and during which the allied French and Venetian armies under Francois I and d'Alviano defeated the allied Italian and Swiss armies. The carnage was very great, as 12,000 of the conquered and 4,000 of the victors were left dead and dying on the field. Trivulzio, who had been present in 18 pitched battles, called them all child's play compared with this "combat of the giants."

**THIRTY-FOOT PLUNGE.**

With his assistance Mr. Moore was able to walk to the top of the mountain where the light car had been left. He will be all right in a few days, but he realizes he had a close call. His wife arrived Monday from Berkeley for a visit at the ranch. She did not learn of her husband's accident until she reached Ashland.—Record.

**News Paper and Pulp Industry.**

Two-thirds of the newsprint paper used by American newspapers is imported or is manufactured from wood or pulp in Canada. One third is made in the United States. The former proportion is steadily increasing, the latter is steadily decreasing.

Forests of wood suitable for pulp making are being exhausted in the northeastern states. At the present rate of depletion none to speak of will be left at the end of ten or twenty years.

**ASHLAND RECORD ON TELEPHONE SITUATION**

**Ashland Editor Explains Telephone Situation.**

The following article is as it appeared in Pacific Record Herald for Sept. 11, 1919.

The article shows a thorough understanding of the matter and we are forced to agree with the writer of the article.

**THE TELEPHONE FAKE.**  
Inconsistency of New Rates Exposed by Hearing at Medford.

The company seems to base their application for permission to hold up the public on the claim that they have \$465,000 invested, and if the rate raise is allowed on this basis the old telephone rate ought to be reduced 50 per cent instead of raised 50 per cent. This would make the rate on a par with the services.

Residence phones ought to be about 75 cents per month and business phones \$1.50 to \$2.00, as this would be about the same ratio to the old prices as \$175,000 possible valuation is to \$465,000 claimed valuation.

The local phone company seems to think that they are entitled to the same exchange rate for their few hundred phones that a city exchange receives for services when the "phone book" contains thousands of names. They don't seem to feel the same way towards their operators. Their wages are based on the village exchange rates. But the Jacksonville toll rate seems to be the "last straw."
