Circuit Judge Thomas is hearing a case in circuit court here today. A week from next Monday—Feb. 4—circuit court will be in session again. Medford-Jacksonville-Ruch Road to be Paved

Work to Commence About March 1

As mentioned in our last issue, a committee was sent out over the county by our chamber of commerce with petitions asking the county court to use road funds, already available, in paving the highway from Medford to Ruch. The committee spent a couple of days in making the rounds of the county and secured the names of more than 1600 of Jackson county's leading citizens, business men and taxpayers, asking the court to proceed at once with the work of paving this road. More than 400 of these names were secured in Medford, about 300 in Ashland, 300 in Jacksonville, every resident in Applegate valleys and large numbers from Central Point, Gold Hill, Phoenix, Talent, Eagle Point, Butte Falls and from all over the county.

The petitions were presented to the county court on Wednesday at 2 o'clock by Mayor Britt. The large circuit court room was crowded with interested citizens from all over the county to hear the arguments for and against the proposition. The principal speakers in favor of the paving were Judge Watson of Ashland, Lawyer Charley Reames, Banker W. H. Gore and Wm. Gates of Medford, Miles Cantrall of Ruch and several local citizens. All of them were favored with thunders of applause.

There was scarcely any opposition to the paving, as only half a dozen or so people in the county were found who refused to sign the petitions, and they gave no reason—except that they were "forninst" signing any kind of petition. Several parties from Medford, who were present at the meeting, suggested that it might be well to postpone the work for some time yet—without giving any reasons why—but their remarks evidently fell on unsympathetic ears, as the unanimous sentiment of those present was in favor of having the work done at once without any more unnecessary delay.

The court—comprised of Judge Gardner and Commissioners Bursell and Alford—took the matter under advisement until Thursday evening, when the decision was made to pave the road.

Just as soon as the court can determine the kind of paving to be used, bids will be advertised for and it is expected that all will be in readiness to start the work about March 1st.
