ITEMS OF INTEREST GLEANED BY SCISSORS EDITOR

Klamath News: Fifteen bright new kegs of moonshine containing 110 gallons which would retail on an active market for over \$1500, a big six Studebaker car a Chevrolet roadster and two disgruntled prisoners, A. Bolla, of San Jose, Calif., and L. Mariano, of Santa Cruz, Calif., fell into the hands of the Klamath county sheriff's office Wednesday afternoon through the alertness of Deputy Sheriff George Dietsch, who is given credit for one of the most successful hauls reported here for some time.

Mrs. Lucian Applegate is seriously ill at her home in Swan Lake. Mrs. Applegate has been in poor health for some time.

Klamath Herald: Death or serious injury came close to Mrs. Detz, of Ashland, a tourist at Crater Lake park, when she lost her balance and fell over the rim at Crater Lake Lodge yesterday morning. According to Colonel Thompson, head of the park, Mrs. Detz fell 75 feet down a slide. She incurred severe bruises but no fractures. A rope was used to pull her back to the top of the rim.

Medford Clarion: The funeral of the late Mrs. Josephine Rhoten, who died at Hill, Calif., on August 8th, was held at the Log Cabin cemetery, near Ruch. Mrs. Rhoten was a resident of the Applegate country, having gone to Hill about a year ago in the hope of regaining her health. Deceased was 63 years old. She was married to Abraham L. Rhoten 38 years ago, and besides her husband three children of this union survive her, also two sons by a former marriage.

Medford Mail Tribune: An auto excursion to the lava beds near Klamath Falls, where the Indians made their last stand in the Modoc war, 51 years ago, will be made Thursday by a party of prominent men interested in Oregon history. The party will include Captain O. C. Applegate, a Modoc war veteran; Jeff C. Riddle, author of a history of the Modoc war and son of a Modoc princess; Dr. John B. Horner, professor of history at the Oregon Agricultural college; the Rev. Charles Hulet, pastor of the First Presbyterian church at Merrill, and A. M. Zevely, county school superintendent of Sherman county.

Two cases involving the right of states to require children between the ages of 8 and 15 to attend public schools were docketed August 14 in the United States Supreme Court. The appeals were brought by Governor Pierce and Attorney General Van Winkle of Oregon and District Attorney Myers of Multnomah county of that state. Proceedings instituted by the Society of the Holy Names of Jesus and Mary and the Hill Military Academy in the federal district of Oregon, contesting the constitutionality of the law on the grounds that it would prohibit children from attending parochial and private

A RELIC OF 1848

Mrs. H. M. Johnson of this city has a copy of The Californian, printed in San Francisco, the copy being of the issue of March 15, 1848.

This week we received a copy of The Pacific Printer containing an installment of a history of printing in California by Charles A. Murdock, from which we quote the following in regard to The Californian:

"The editor, Rev. Walter Colton, S. N., in his 'Three Years in California,' gives an interesting account of the birth of the journal in his diary August 15, 1846. He writes:

"Today the first newspaper ever published in California made its appearance. The honor, if such there be of writing its prospectus falls to me. . . . My partner is an emigrant from Kentucky who stands six feet eight his stockings. He is in buckskin dress and coonskin cap, is true with his rifle ready with his pen, and quick at all type case."

The paper was first printed in Monterey and the first issue was printed on wrapping paper used to envelop tobacco that was shipped in to the natives. Some of the difficulties experienced may be imagined from the following paragraph taken from an early number: "Our type is a Spanish font picked up here in a cloister, and has n v's in it, as there is none in the Spanish alphabet. I have sent to the Sandwich Islands for this letter. In the meantime we must use tvvo v's. Our paper at present is that used for wrapping cigars. In due time we will have something better."

Further on, the historical skete says: "It became evident that Monterey was no place for a paper and in May, 1847, Robert Semple issued the first number of Volume II of the "Californian" in the recently named city of San Francisco. A careful census on June 1, 1847, gave the community: White men, 191; women, 7 children, 107; Indians, 34; Sandwich Islanders, 40; negroes, 10; total, 459.
