CANADA AT ALBANY.—A company has been organized at Albany, Oregon, for the purpose of running the fruit of the surrounding country, of which hundreds of bushels have been yearly allowed to go to waste.

EXTENSION OF THE PALOUSE R. R.—The contract for the extension of the Spokane & Palouse railroad from Belmont, Washington Territory, to Coeur d'Alene, Idaho, has been let to Nelson Bennett. The line surveyed last fall via Palouse City has been determined upon. The length of the line to be constructed is sixty-five miles. The distance from Spokane to Belmont is fifty-two miles, which makes the length of the entire line one hundred and seventeen miles. Work will be pushed and the road constructed by the first of September, ready for the use of the public.

BONNEVIE & SISTER'S COAL LINE.—A company has been incorporated, with a capital stock of \$1,000,000.00, for the purpose of constructing a railroad direct to Butte and Anaconda, via Red Bluff and Piney; also to Trail creek and the Yellowstone river. The direct object of the company is to secure a line from the Trail creek coal mines to Butte and Anaconda, for the purpose of supplying coal to those and other mining camps. The project is supposed to be in the interests of the Northern Pacific, Union Pacific or Montana Central. Surveys have been in the field several weeks.

BONNEY CREEK MINE.—The output of the coal mine at Bonney, W. T., on the Cascade division of the Northern Pacific, is four hundred tons a day, and an average of three hundred and fifty tons. This coal is all taken from one vein, which it is estimated will furnish three hundred million tons. The company owns about thirty-five quarter-sections of coal about Bonney, Cle Elum and Troutway. It is good property, and could be bonded for \$1,000,000.00 if the company would take it. But it would take a stiff company to operate it, even at its present working. It is intended to open up another vein this summer. The present vein is five feet.

ELBERTON, W. T.—Twelve miles from Colfax, W. T., on the line of the Farmington branch of the O. H. & N. Co., a new town, called Elberton, is springing up. It possesses good water power in the North Palouse river, which flows through the town site. A saw mill is in operation, and a large roller-process flouring mill is being erected. The town site is the property of S. M. Wait, to whose energy and business capacity the founding and prosperous growth of Walla Walla and Dayton are largely due. The new town is surrounded by a splendid agricultural country, already under cultivation, and will no doubt grow rapidly. It offers good business opportunities, which those in search of a location for trade and manufacture in a thriving country town, would do well to examine.
