ereligious preference and sexual orientation? The Rev. Gary Wilson, pastor of Metropolitan Community Church, had a different slant on the gathering of assholes. "The seminar, or whatever they called it, was nothing but a program upholding homophobia as a positive value to society. Everything I heard them say, I've heard them say before," Wilson (who is not an asshole) commented.

"It was a thinly disguised kickoff for their campaign against Gov. Goldschmidt's executive order. They passed out petitions and voter registration forms."

Commenting on the assholes' distance from reality, Wilson said, "They cannot even deal with AIDS information separate from their homophobia. For example, they discussed the need to establish a hospice house where PWAs will be hounded to repent of their homosexuality."

Amtrak OKs same-sex family fares

gay couple's refusal to accept bureaucratic obfuscation has led to clarification of Amtrak's policy on family fares. On May 10, Walter Wheeler was not permitted to buy an Amtrak Family Plan ticket for himself and his partner of five years. Under the Family Plan, a head of household pays full fare and the other adult family member pays half fare; children between two and eleven years of age pay onefourth fare.

"This is just another example of the day-today discrimination that costs our families more money for the same service," Wheeler said. Wheeler and his partner, J. Carey Junkin, are president and executive director, respectively, of Couples Inc., the National Organization for



Family Diversity. Wheeler added, "I believe we must stand up for rights, even over small issues. Otherwise we will not receive equal treatment and may even lose the rights we already have."

Wheeler and Junkin were not willing to accept the opinion of a ticket clerk who held to the position that Family Plan tickets are for legally married couples only. In a telephone conversation with John Jacobsen, director of community affairs for the National Railroad Passenger Corp. (Amtrak), the official policy was clarified. Amtrak issues Family Plan tickets without regard to the sex of family members. The policy, changed in 1985, is meant to be nonjudgmental; no inquiry is to be made of the family's legal status, and no proof is to be required. Couples must be willing to say they are "married," however, because the official policy requires that the half-fare adult be a spouse.

or the first time in Oregon's labor history, lesbians and gays who are members of lesbians and gays who are members of organized labor will march as a united group on Lesbian and Gay Pride Day this year.

Lesbian and Gay Unionists has gathered momentum since Jimmy Bryan, a staff secretary with the Oregon Public Employees Union, promoted the idea at OPEU's annual women's conference in March.

"It is time for gays and lesbians to come out one more time. It is time for our brothers and sisters in the labor community to recognize the value and contributions that lesbians and gays have made to the labor movement in its rich history and continue to do today," Bryan said.

Hate-crimes bill passes House

bill requiring the federal government to keep figures on crimes motivated by prejudice passed the House of Representatives by a 383-29 vote after an attempt to remove attacks on lesbians and gays from the crimes list was overwhelmingly rejected. Oregon's congressional delegation split on party lines; Democrats Les AuCoin, Ron Wyden and Peter DeFazio voted with the majority. Republican Bob Smith voted against the bill.

A hate crime is "an act of violence which is accompanied by an additional motive: an attempt to intimidate a larger group or class of people," according to Rep. John Conyers Jr. (D-Minn.), chairman of the House Judiciary Subcommittee on Criminal Justice, which held extensive hearings on the bill since it was introduced in September 1987. The bill had 109 sponsors, the largest number ever to cosponsor a measure containing a sexual-orientation clause, according to the National Gay and Lesbian Task Force, which assembled a coalition of 53 organizations to lobby for the bill.

"Hate and violence motivated by sexual orientation more than doubled between 1985 and 1986. To me, it is a grave injustice to tell thousands and thousands of victims that their pain, their suffering and their fear are unworthy of the attention of a government that is supposed to safeguard the rights and freedoms of all Americans," Rep. AuCoin said in opposing the amendment to delete that category from the bill.

A substitute amendment, submitted by Rep. John Miller (R-Wash.), that defines sexual orientation as "homosexuality or heterosexuality" and states that "nothing in this act creates a right for an individual to bring action complaining of discrimination based on homosexuality" passed by a 383-30 vote.


