he Quilt, sponsored by The Names Project: Oregon/Southwest Washington, will be displayed at the Earle A. Chiles Center, University of Portland, on July 28, 29 and 30.

An opening ceremony, featuring a partial unfolding and the reading of names of men and women memorialized on the 170,000-squarefoot folk art piece, will be held on July 28, beginning at 7 pm.

On Friday, the Quilt will be displayed between 10 am and 9 pm.

A closing ceremony for both the Portland display and the 20-city national tour will begin at 7 pm on Saturday, July 30. Members of The Oregon Symphony, the Portland Gay Men's Chorus, the Portland Lesbian Choir, jazz vocalist Shirley Nanette and others will participate in the closing.

Bill Hudson and Cindy Williams are coordinating celebrity involvement in the project from their residence in Malibu, California, and are approaching Oregon entertainment figures who live in California, encouraging their participation in the Names Project Quilt.

The Steering Committee of the Names Project: Oregon/Southwest Washington announced at its June 23 meeting that the funds raised during The Quilt's stay in Portland will be divided evenly among the Cascade AIDS Project, Portland; Douglas County AIDS/ARC Council; Shanti in Oregon; and Southwest Washington AIDS Council, Vancouver. Funds allocated to these groups are earmarked for direct services for persons with HIV disease.

All Quilt events during the three-day showing are open to the public and are free.

"Just Out" receives Demo convention nod

emocratic National Convention Credentials Chairman Neel Lattimore announced on June 15 that Just Out had been accorded press credentials to the convention. The Democratic National Convention is scheduled for the third week of July in Atlanta.

'Every major press organization in the country has made application to be represented at the convention," stated Lattimore. "We'll have 15,000 press people from 7,000 outlets from all over the world. Just Out will be one of only six gay and lesbian news teams at the convention, but we hope to maximize this converage by providing every opportunity to the six.'

Just Out's application for credentials was supported by Portland City Commissioner Mike Lindberg, who said, "Just Out is a monthly news magazine that serves as a major source of information in the State of Oregon about the issues of primary concern to the gay and lesbian community."

Congressman Les AuCoin, in support of the press credentials, said, "In the five years of its existence Just Out has grown in scope and stature. The reporting is balanced and fair."

Just Out has joined with Jackson alternate delegate Randy Sullivan to raise expense monies for the trip to Atlanta. Contributions should be made to Oregon Pride Delegation, PO Box 15117, Portland, OR 97215. Funds raised in excess of expenses will be passed on to Oregonians for Fairness (OFF), a new community-based organization fighting the ballot measure to overturn the Governor's executive order protecting some state employees from discrimination based on sexual orientation.

United Way OKs Phoenix Rising request for funds

Inited Way has approved a request for funds by the Phoenix Rising Foundation, a Portland gay and lesbian counseling agency. The approval was announced on June 27 by York Haines, United Way's vice president of communications.

According to Haines, \$16,000 was approved by United Way's board of directors because Phoenix Rising has demonstrated a need for broader outreach into an "under-served population." Said Haines, "This funding request approval will improve the overall focus of United Way and has been actively supported by local corporate United Way supporters."

Helen Lottridge, director of Phoenix Rising, acknowledged the importance of the United Way funding, saying that this action will serve as an "important step" in her organization's mission to serve the gay and lesbian community.

he murder trial for Cheryl McBride has been postponed until September 20 been postponed until September 20, 1988. The location will still be Newport, Oregon. A continuance was ordered to assure that all witnesses will be available to

Pledge a picketer

icketers at the Portland Feminist Women's Health Center, in addition to raising commotion and ire, will be raising money for the clinic this summer — in spite of themselves. The Pledge-a-Picketer program, organized by clinic staff and volunteers, asks individuals to pledge money — as little as one cent per picketer - for every picketer who shows up at the clinic between July 1 and September 30.

"We'll post a thermometer on the side of the building on Saturday mornings showing the picketers how much money has been raised by their attendance," said John Duke, volunteer escort coordinator for the health center, located at 6510 SE Foster Road.

Since 1983, the health center's Saturday abortion clinics have been picketed by antiabortion protesters, who taunt clients, staff and volunteer escorts with cries of "murderer" and impromptu sermons on the sidewalk. A temporary injunction forbids picketers to enter a 25-foot "safe" zone around the clinic door.

Duke said an average of five to 15 protesters may show up at the clinic on a typical Saturday morning. A contributor who pledged five cents per picketer, assuming ten picketers came each Saturday, would owe \$6.50 at the end of the summer. Pledge-a-Picketer organizers will mail cards at the end of each month telling pledgers how many picketers were present and how much money they owe.

Will picketers be discouraged from showing up by the knowledge that they're helping the clinic? "I think it will help," said Duke. "Anything we can do to relieve the pressure and take a little wind out of their sails. . . . "



Begun by Frank Schreckenberger, Rose Emperor V, and Kurt Meyer, Rose Empress XXI, the scholarships are given based on financial need, clarity of educational objectives and the applicant's gay and lesbian community connection.
