
#### HALLOWEEN '89 IN KEY WEST — AND A THREE-DAY CRUISE TOO! OCT. 26-30

# Carrsyn health fund established

aureen Carrsyn, a long-time member of the Portland lesbian community, was diagnosed late last year with breast cancer. She had had regular breast examinations and caught it before it reached a painful stage. Carrsyn underwent a mastectomy in January. She is expected to make a full recovery.

Carrsyn has health insurance through her employer, but she still faces \$2,600 in expenses. A number of benefits produced by women who have known her for many years have been held to raise the necessary funds.

Raising the money has also raised a number of questions few of us had personally addressed. What of other women, like me, who have no health insurance? The treatment Carrsyn received cost many thousands of dollars; how many of us could afford it?

Also, how well do we take care of our bodies.

How often do we check them to make sure all is in working order? Had Carrsyn not had regular mammograms, the cancer would have been much more serious. The diagnosis was made before there was a lump in her breast.

Fundraising efforts on Carrsyn's behalf are continuing. All money raised above the \$2,600 goal will be placed in a trust fund for women in our community who find themselves in similar situations. Contribute what you can, and heed the warning: cancer, and other diseases, can be cured if caught early. Carrsyn never did *feel* sick. Had she not had regular check-ups or had she waited until she knew something was wrong, the prognosis might have been much worse.

The response from the community has been positive; women have pitched in, donating time, money, and energy.

## Recommended reading

Report on Gay and Lesbian Youth in Seattle by Seattle Commission on Children and Youth. 105 Union Street, Suite 160, Seattle, WA 98101.

An excerpt from the Executive Summary of the Report follows:

The Report includes 21 recommendations for the City of Seattle, Seattle Public Schools, agencies providing social and health services to youth and families, and the media. Major recommendations seek to address the needs of young people for accurate, objective, and relevant information about sexual orientation, supportive counseling and other social services, and protection from harassment and discrimination.

For example, the Commission recommends that the Seattle School District incorporate appropriate information about sexual orientation into the curricula of existing health and family life courses and that teachers receive training about the problems and special needs of gay and lesbian students. The Commission also recommends that the District adopt explicit written policies reflecting prohibition of discrimination in employment on the basis of sexual orientation, as well as harassment of gay and lesbian students."
