of the estimated United States homeless population of two million, a survey has revealed that from 28,000 to 32,000 homeless people have AIDS or AIDS-related complex. Even worse, it is forecast that this AIDS group is likely to increase by 87 percent in just the next year.

Imagine being homeless and having to deal with AIDS!

The report was issued by the Partnership for the Homeless, Inc. of New York City. It was based on questionnaires circulated to more than 500 public and private agencies in 46 cities and localities nationwide.

The Partnership also proposed a national agenda for dealing with the issue of homelessness and called for an increase in the minimum wage, modest increases in the Earned Income Tax Credit for the working poor, and uniform minimum amounts for welfare benefits, which now vary greatly from state to state.


Nearly one-third of the nation's homeless people are impaired by alcohol or drug dependency, and about one in five suffer severe mental illness, according to that survey.

allowed him to use a guidance counselor's office at night to make phone calls to set up appointments for his prostitution service.

Lawmakers should move against hate crimes

A ccording to The New York Times, the only thing standing in the way of a New York State Assembly law aimed at bias crimes is the unwillingness of some legislators to include "sexual orientation" as a protected category.

The racial attack at Howard Beach three years ago and the recent series of harassments against Jewish students have attracted all the headlines. Yet attacks on homosexuals — or those thought to be homosexual — are said to be the fastest-growing category of bias-crimes in the nation.

Congress is also mulling a bias crime bill that would authorize the United States Justice Department to gather national statistics on hate crimes. Incredibly, no such statistics are being compiled.

New York's proposed bias-crime bill would authorize prosecutors to upgrade the severity of the charge against an assailant in such crimes.

There is a plastic surgeon in Seattle — Dr. Curran Smith — who wanted his fellow doctors to consider it ethical to require an HIV test from all patients before elective surgery. Not only that, in a proposal to the 100th annual meeting of the Washington State Medical Association in Spokane recently, Dr. Smith asked his fellow doctors to also consider it ethical to refuse to perform elective surgery if the patient refused to take the test or if the person is carrying the virus.

"The doctors are saying that, just because an individual has a disease in which there may be a risk to the physician or health-care team, medical care should not be withheld," Dr. Schneider added.
