#### AIDS forum to air monthly

Bent Communications is producing a program on local cable channels which the producers hope will demystify the AIDS epidemic. The programs will consist of five 10-minute segments featuring technical-medical personnel, lay people involved in the crisis, PWAs and others with HIV infection.

The program will debut on Cable Channel 11 on January 25 from 8 to 9 pm, and will continue on the fourth Thursday of each month thereafter. As with most cable programming, AIDS Forum Live, will be rebroadcast at other times during the month. Check local television schedules or call 288-1515 for more information.

## Starlight Parade float

The committee which organized the float last year does not want to do it again, although individuals are willing to consult and assist a new group. Cost of the project last year was about \$8,500, and in addition involved many volunteer hours in fundraising, planning and organizing.

The Lesbian Community Project has been approached to coordinate the project, but before a decision is made LCP is seeking input from LCP members and from the larger gay and lesbian community regarding the value and relevance of expending energy and money in this direction.

Many LCP members have already expressed their feelings about the float project; anyone who feels strongly about doing or not doing a float is encouraged to express their opinions at this time. ## AIDS Hotline training dates set

The Oregon AIDS Hotline will be holding a training series for new volunteers in January and February. The training dates are January 20, 27, and February 3.

The Oregon AIDS Hotline is a joint project of Cascade AIDS Project and the Oregon State Health Division. Begun in 1987, the Hotline receives calls from Oregon, Washington, and other states as well. With a current average of 600 calls per month, the Hotline manages HIV-related information and referrals. A new Computer Information System assists Hotline volunteers with most calls. The system contains a database of all Portland area resources for those concerned about HIV. In addition, the system supports the AIDS Compact Library compact digital disc program containing six interrelated databases of information. The Hotline is open seven days a week, with all calls answered by professionally trained volunteers.

Hotline volunteers attend 21 hours of formal training, followed by 12 hours of training on the job. The formal training includes segments on basic HIV information, risk reduction and safer sex techniques, HIV antibody and antigen testing, medical treatments, crisis intervention techniques, active listening skills, and more. No previous experience is required and volunteers are asked to commit to one four-hour shift on the phones each week for six months.


The next training will be limited to 20 people. Those interested in participating should call Cascade AIDS Project administrative office and ask for a volunteer application (223-5907).


