#### Voice in the wilderness



# Illinois high school adopts gay rights policy

The headline on the front page of the Windy City Times was a delightful shock: "High School Adopts Gay Rights Policy." The story was even more heartening; after a year of many defeats to gay and lesbian rights across the nation, gays and lesbians and their supporters were finally able to buck right-wing fundamentalist opposition.

By unanimous vote, the Oak-Park River Forest (Illinois) High School board moved on December 13 to add the words "sexual orientation" to the list of protected minority groups named in the school's Human Dignity and Diversity Policy. With the board's move, the high school became the first public school in Illinois (and the nation?) to adopt a gay rights policy for students and faculty.

The school board's move followed passage of gay rights legislation by the Oak Park village board in June, 1989. The village board's revision to its Human Rights Code also passed by unanimous vote. But it took six months of hard work by lesbians and gays — many of whom came out during the campaign — and the help of students, parents, and the local press, who saw through the opponents' campaign of homophobia and hate.

The Oak Park-River Forest victory should be an example to communities across the country that the right-wing religious crazies can be overcome.

#### Where is Diane Wells?

Diane Wells was four years old on October 1, 1989; that was the day her mother disappeared with her. Diane's father, Bill, and mother, Amy, are divorced. Amy Wells was awarded sole custody of Diane, with certain visitation rights accorded to Bill.

Bill and Amy Wells's divorce decree stated that at age four, Diane would be allowed overnight visits with her father. Bill is gay and he believes that his ex-wife hatched a plot with her family and church that she would disappear with Diane when Diane reached that age. Bill says that Amy's plan was supported by the Church of Christ in Beaverton. Bill believes that Amy is hiding with Diane because of the fact that he is gay.

Bill Wells hired a private detective who reported suspicions that Amy and Diane are being hidden someplace in Vancouver, Washington, but found nothing conclusive to confirm the suspicions. Bill consulted three different attorneys but the costs were prohibitive and he learned that he would have to find Amy and Diane himself, in any case, because Amy has full custody.


