Munsell and her alleged target are no strangers to the courtroom. Earlier this year, Munsell sought and obtained a restraining order against her ex, which she then rescinded a few months later.

Less than a week before her arrest, Munsell had been denied an attempt

for an emergency custody change in which she sought to have all parental visiting time withheld from her ex.

Emergency custody orders generally aren't approved unless one parent can establish that the other parent poses an immediate threat to the child's safety. Munsell's claims fell short of that, and Judge Greg

Baxter denied her request.

District Attorney Matt Shirtcliff said that additional charges are possible following the Grand Jury, but doesn't expect the case to reach the Grand Jury for at least another week.

More information will be released from the District Attorney's office at that time.

Patrol car damaged

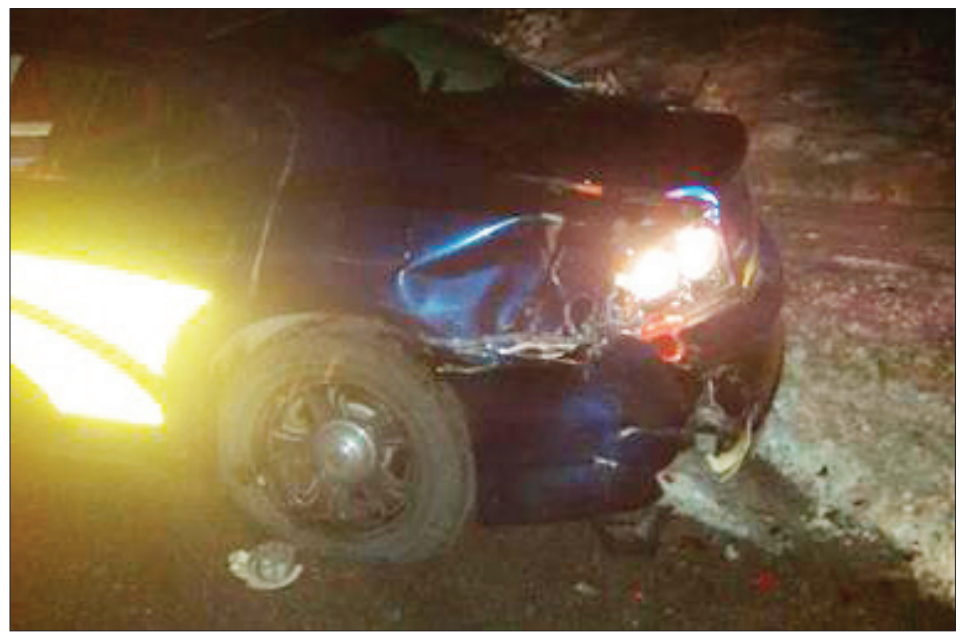
