Kidnapped woman saved by 911 call in northeast Oregon

On June 27, 2015 at about 6:12 a.m., the Morrow County Sheriff's Office received a 911 call from a female who advised she had been kidnapped and was trapped in a car traveling on I-84.

Members from the Morrow County Sheriff's Office, Gilliam County Sheriff's Office and Oregon State Police responded and located the vehicle on I-84 traveling westbound

near milepost 143 (east of Arlington).

Law enforcement stopped the vehicle and the driver was identified as William T Cooter II, age 42, of Greeneville, TN. The female was located inside the vehicle and identified as the person who called 911.

A roadside investigation revealed Cooter had assaulted and held his female passenger against her will.

Further learned was Cooter and the victim did not know each other prior to the incident.

Several Baker City residents said they believe they saw Cooter in town the day prior looking for employment.

Cooter was arrested and was lodged at the Northern Oregon Regional Correctional Facility in The Dalles on the following charges: Kidnapping 1st

Degree, Rape 1st Degree, Sex Abuse 1st Degree, Sodomy 1st Degree, Assault IV, Coercion, Menacing, Unauthorized Use of a Motor Vehicle, Unauthorized Entry into a Motor Vehicle, Criminal Mischief 2nd Degree, False Information to a Police Officer, Possession of Methamphetamine, and Interfering with Making a Report.
