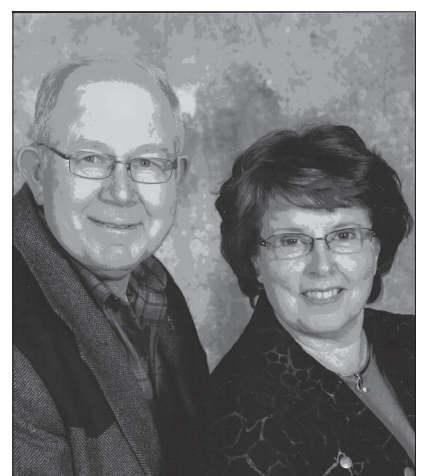

Bill loved to follow the rodeo and was a bull rider. He also loved to hunt and enjoyed the outdoors.

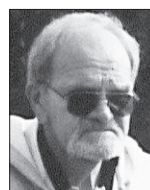
