When Dave was close to retirement another Schwab friend was selling some property in Unity, he ended up purchasing the land and never looked back. He loved living in Unity as it provided all the things he loved to do, hunting, fishing, and being outdoors,

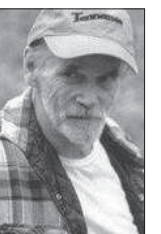
