The two new drivers, Robert Dillard and Orvoll Rae, are both now fully employed by the Traction company. Their employment followed routine practice runs with the public transportation firm. Dillard was used on the Bridge Transfer line and Rae on the Killingsworth.

Dillard Combat Veteran

Dillard, 532 N. Fremont street, is married and a World War II combat veteran, serving with the 92nd division in Italy. He is a native of Paris, Tex., and came to Portland in 1945.

He attended barber's school at the Northwestern Barber college and worked at Shine's barber shop, as a waiter on the Union Pacific railroad and at the Portland Air Base barber shop before getting the job opportunity with the Traction company.

His wife works as a telephone operator for the Pacific Telephone company.

Rae is a native of Antlers, Okla. He came to Portland in 1942. He lives at 3222 N. Gantenbein avenue.

The hiring of Dillard and Rae culminated his conferences with Steele and Foss.



Isaac Alford Gets Athletic Club Post

State Adopts Equality Bill

Oregon became the 22nd state to put into effect a civil rights bill when the equal rights measure passed by the 1953 Oregon legislature became law and active July 21.

The bill was protested by a group called the "Civil Freedom Committee" and a referendum petition filed by John F. Reynolds, attorney of the organization, managed to scrape up only two per cent of the necessary 23,375 signatures needed to hold the law in abeyance until the 1954 state elections.

Race Bias No Basis

Oregon's civil rights law makes it illegal for public eating, lodging and amusement places to discriminate against any person because of religion or race. The bill provides for civil damages up to \$500.

The "Civil Freedom Committee" suffered two setbacks when the state supreme court ruled that the petition title had to be rewritten and that employes would be unable to solicit signatures while working.

The title change was contested by the Oregon Committee for Equal Rights, a state-wide organization instrumental in the introduction of the bill.

Education Helped Bill

In 1950, Portland's city council unanimously passed a similar civil rights ordinance which was later turned down by the people.

Civil rights proponents attributed the failure to low propaganda tactics by the opponents of the measure and attribute much of the success of the new bill to the education brought about by the publicity given the defeated city ordinance.

Funeral services were held recently for Dudley Williams who died here July 1. The services were conducted by the Billy Webb Lodge No. 1050, IBPOE of W in the Zeller Funeral chapel.

Interment was at Columbian cemetery.

Born in Fairmount, N. C., October 10, 1914, Mr. Williams was the husband of Olga Williams, He lived at 1468 N. Wheeler street and worked on construction jobs as as air tool operator.
