

# Clackamas County gets grant to help veterans train for jobs

Community Solutions for Clackamas County (CSCC) has been awarded a \$750,000 grant from the U.S. Department of Labor's Veterans Workforce Investment Program to continue to help veterans statewide train for and find jobs.

Labor's Community Service Agency, AFL-CIO, and the Oregon State Employment Department are contract partners in the project.

Through the grant, veterans receive skills assessments, individual job counseling, labor market information, classroom or on-the-job training, skills upgrading and retraining and placement assistance.

For its part, Labor's Community Service Agency is helping veterans get plugged in to construction apprenticeship training programs.

LCSA Executive Director Glenn Shuck has made program presentations to union organizations, conducted mailings to distribute veterans program information, staffed informational booths at veterans events and referred veterans to appropriate services.

"The success of our program is built upon strong partnerships between state workforce systems, organ-

ized labor and businesses who want to see our Oregon National Guard, Reservists and enlisted military personnel successfully transition to civilian employment," said Maureen Thompson, CSCC director and grant recipient.

The Clackamas County award was one of 12 Veterans Workforce Investment Program grants announced by the Labor Department and the only West Coast grantee. The awards totaled \$6.7 million.
