The conference is designed for business managers, business agents and union officers, to provide information that will help them do their jobs better and to help avoid legal liability.

In addition to classes on basic grievance handling and how to obtain documents for arbitration, guest speakers will discuss legal secondary boycotts, the rules on using social media and Working America.

Gordon Lafer of the Labor Education and Research Center at the University of Oregon will talk about a right-to-work ballot measure aimed at Oregon, and LERC Director Bob Bussell will discuss the Affordable Care Act and its impact on unions.

Guest speakers include Ronald Hooks, director of the National Labor Relations Board, NLRB 19, and Sub-region 36 Officer in Charge Linda Davidson.
