## Postal rally slated Dec. 14 at Jantzen Beach Staples

Staples and the U.S. Postal Service have cut a deal that jeopardizes the nation's public post offices, the sanctity of the mail, and thousands of good living wage jobs. Staples has contracted with the USPS to staff mini-post offices installed within their stores with low-paid, nonunion, non-postal workers (the av-

erage Staples worker makes \$18,000 per year). Beginning with 82 pilots in 2013, the USPS announced last October that it plans to open post offices inside all 1,500 Staples stores nationwide, including Portland.

A "U.S. Mail Is Not for Sale!" rally has been planned to protest this action. It will be held Sunday, Dec. 14, at 1 p.m. at Staples Jantzen Beach, 1805 N. Tomahawk Dr., near Jantzen Beach Target.
