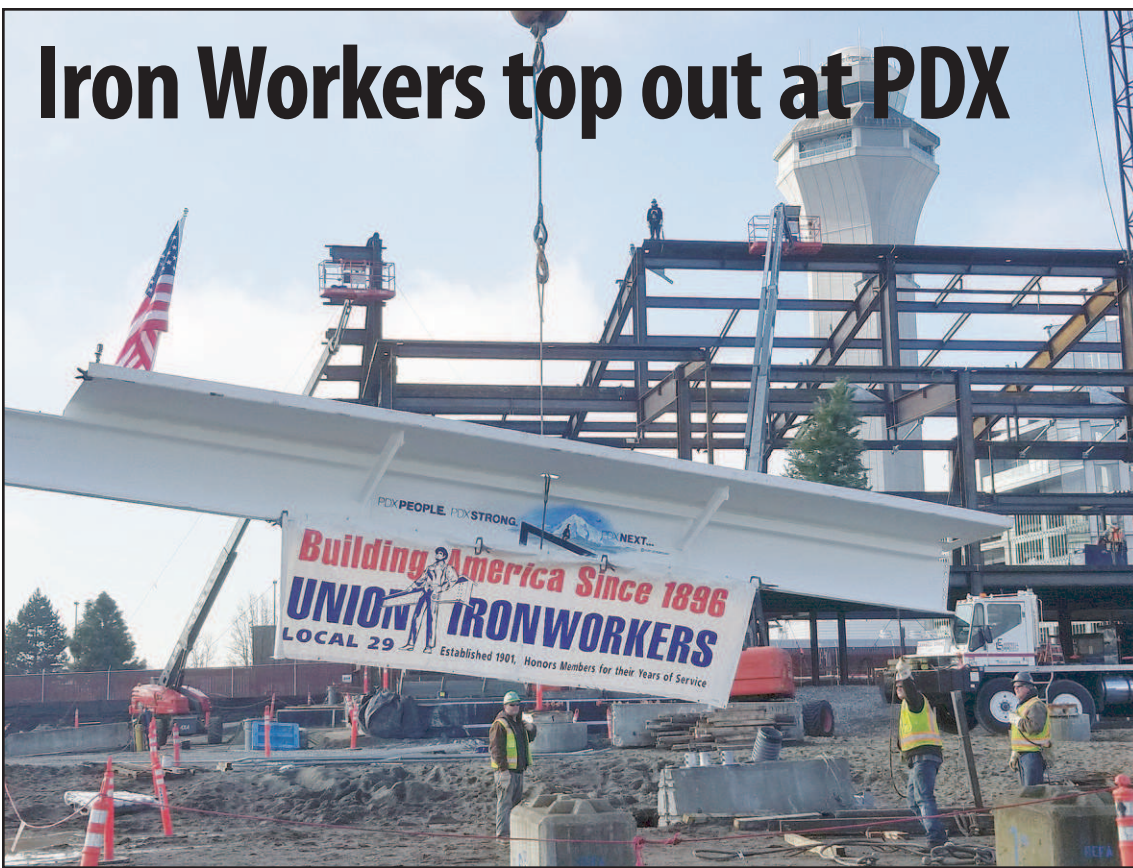


Iron Workers top out at PDX



Iron Workers placed the final steel I-beam on "Concourse E" at the Portland International Airport Feb. 21. The project is part of PDXNext, a \$2 billion series of five large construction projects at the airport. It's the first new terminal construction at PDX in 20 years. Concourse E will be the new home for Southwest Airlines and is expected to open in the summer of 2020. Other improvement projects will continue until at least 2025. Additional educational documents, résumés, and letter of reference are also helpful for scoring purposes.

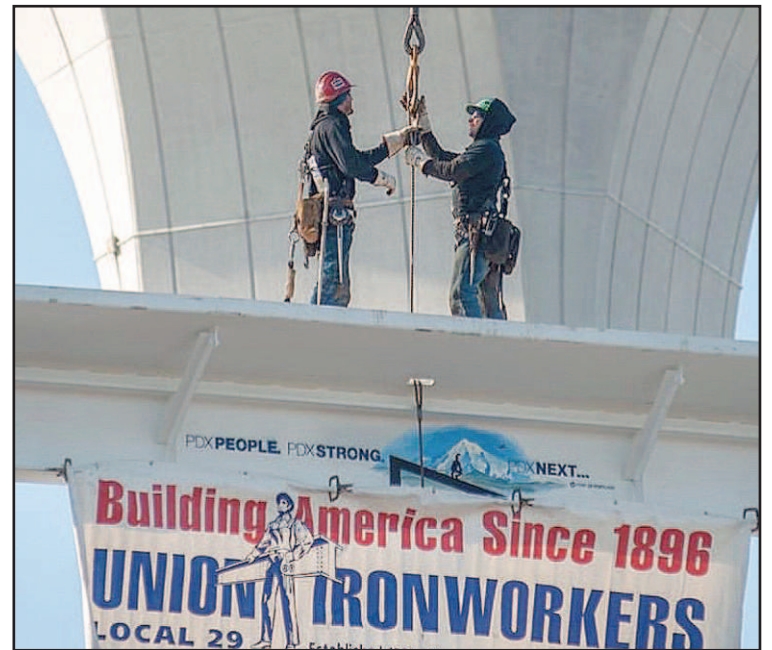
