Portland Jobs with Justice Scrooge of the Year party

Portland Jobs with Justice has announced the nominees for its annual Scrooge of the Year Award. The award — given to an individual or entity that was particularly hard-hearted to workers — is chosen at an annual holiday party that raises funds for the workers rights group.

This year attendees will choose from six nominees: Burgerville, for bargaining in bad faith and terminating leaders and supporters of the Burgerville Workers Union; billionaire Amazon CEO Jeff Bezos, for exploiting close to a million workers worldwide in sweatshop conditions; Koch Industries for funding a nationwide anti-worker agenda

and forcing boat workers to work for 60 days straight; Mike Nearman, Oregon state director of the anti-union Freedom Foundation; OHSU Management Bargaining Team, for bad faith bargaining and creating fake Twitter accounts to troll the union; and Oregon House Speaker Tina Kotek for leading the effort to cut PERS benefits this year.
