

A union guide to Washington's Aug. 4 primary election

Washington's top-two primary is a winnowing out election: The top two vote getters, regardless of party preference, go on to the November general election. July 27 is the last day to register to vote. Ballots will be mailed July 17 and must be return post-marked by Aug. 4.

Congressional District 3 (Vancouver)

Governor

Jay Inslee was once disinclined to speak at the state AFL-CIO convention after defying labor to give Boeing a record-breaking no-strings-attached \$8.7 billion tax break.
