Doctors-in-training at OHSU win contract

Members of a unit of about 850 medical interns, residents and fellows at Oregon Health and Science University (OHSU)—known collectively within their profession as “house officers”—have ratified their first-ever union contract since voting to join AFSCME in 2019.

Announced March 12, the three-year contract runs through March 2023. It raises salaries 2.5% a year, adds a fourth week of paid vacation, and for the first time commits OHSU to pay medical license and exam fees that can top \$1,000 a year. It also includes a \$2,000-a-year housing stipend, which increases 5% annually; a \$1,000 relocation stipend for new staff; and \$500 toward equipment doctors must purchase to do their work, like surgeon’s loupes.

Currently, house officers’ pay ranges from \$67,500 to about \$80,000, about the middle of a pay range that is set by the Accreditation Council for Graduate Medical Education.

Negotiations took almost exactly a year, and were completed with the help of a mediator.

UFCW 555 leaves Northwest Oregon Labor Council

United Food and Commercial Workers (UFCW) Local 555 has disaffiliated from the Northwest Oregon Labor Council (NOLC), citing unexpected expenses incurred over the last few months. The announcement was made by NOLC Executive Secretary-Treasurer Bob Tackett at the March 22 Executive Board meeting. UFCW Local 555 was the council’s largest affiliate.

The withdrawal means three Local 555 delegates who held NOLC office can no longer serve in those roles: NOLC’s president Jeff Anderson, Executive Board member Chris Groener, and trustee Lucy Carrier.

NOLC will accept nominations to fill the three vacant offices at its monthly delegates meetings in April and May, and hold elections at its June meeting if any positions are contested.
