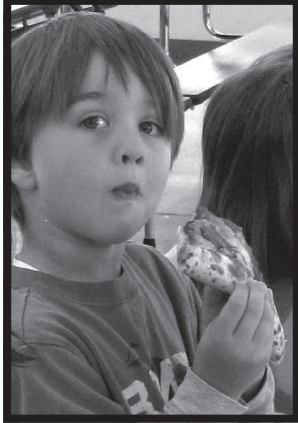

- ☑ All youth under the age of 10 must be with an older sibling, parent or care provider (ORS 163.545)
- ☑ Any youth, under 10, without a chaperone WILL be fed and sent home if they cannot provide name of older care provider
- ☑ All participants WILL have shoes and shirts (T-shirts available to borrow)
