

Robert "Bob" Charles Schwab died June 2, 2017 at the Willamette Valley Medical Center from complications following an operation. He was 90 years old.

Robert was born in Vernonia, Oregon on December 19, 1926 to Lee Schwab and Clara Van Domelen.

Lee, a newspaperman, moved the family to Dufur, then She was preceded in Klamath Falls, where Mother and his four children, Melvin, Bob, Genny, and Lois returned to Vernonia. Bob graduated from Vernonia High School in 1944 and immediately joined the Navy. He served on the destroyer U.S.S. Cowell in the Pacific earning the Asiatic Pacific Medal, WWII Victory Medal, Phillipine Liberation Medal, and a Presidential Unit Citation. He was extremely proud of his service in WWII and was lucky to be on one of the few ships that came thru the picket line at Okinawa without serious damage.
