Notice is hereby given that sealed bids for Construction of the Genzer Rd to Pihl Rd 3 phase Distribution overhead reframe, new underground construction and underground decommission project. The project is located in Washington County Oregon. The approximately 8.6 miles distribution line runs from the intersection of Hoffman Rd and Genzer Rd to its end at pole #872107 along Pihl Rd via the Green Mountain route, with both overhead and underground portions. The Overhead rebuild portion is about 3.4 miles of reframing overhead transmission structures to overhead distribution structures along Genzer Rd and Bacona Rd to John Lee Rd. Approximately 5.2 miles of new 3 phase underground distribution line will be constructed along John Lee Rd, Green Mountain Rd and Pihl Rd.
