NOTICE IS HEREBY GIVEN that the Vernonia Planning Commission, will conduct a public hearing on a request by Joe Riley to vacate a portion of the public street on 3rd Street, adjacent to Weed Ave.

That portion of 3rd street lying west of Block 17, North of the North right of way line of G Street and east of the easterly line of the old Railroad grade described in Deed Book 32, Page 344, Columbia County Deed Records.

And,

That portion of 3rd Street lying west of Block 20, south of south right of way line of G Street, east of the easterly line of the old Railroad grade described in Deed Book 32, Page 344, Columbia County Deed Records and north of the westerly extension of the north line of the alley lying south of Lots 1-6, Block 20, Second Addition to Vernonia.

That portion of 3rd Street lying west of Block 20, north of the north right of way line of F street, east of the easterly line of the old Railroad grade described in Deed Book 32, page 344, Columbia County Deed Records and south of the westerly extension of the south line of

SAID PUBLIC HEARING will be held before the Vernonia Planning Commission on Thursday, April 5, 2018, in the Council Chambers of Vernonia City Hall, 1001 Bridge Street, Vernonia, OR at or after 7:00 pm, at which time proponents and opponents of the proposed Vacation will be heard.

A staff report will be available to the public at City Hall one week before the hearing, and may be copied for a nominal fee. Failure to raise an issue in a hearing, in person or by letter or failure to provide statements or evidence sufficient to afford the decision-maker an opportunity to respond to the issue precludes appeal to the board based on that issue. Public testimony is welcome, and written statements will also be received before the hearing.

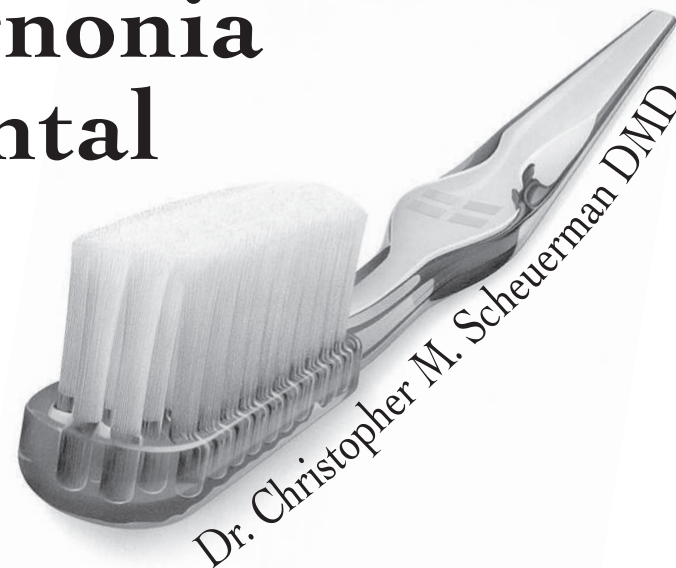
