He was raised in Lincoln and attended Lincoln High School, graduating with the Class of 1956. Paul later attended University of California, Palomar College, graduating with an Associated Arts degree in 1962.

He enlisted into the U.S. Navy and served his country for four years. He was an airplane radio repairman He was honorably discharged in 1962.

He enjoyed living on the farm, caring for his animals, and their small acreage. He also enjoyed tuning violins and had

Reverend Richard K. "Dick" Colsen, 91, a longtime resident of the Hillsboro community, died Saturday morning, April 27, 2019 at his home.

Graveside Services with Full Military Honors were held on Tuesday, May 7, 2019 at 2:00 pm at the Willamette National Cemetery, 11800 SE Mt. Scott Blvd. in Portland, under the direction of the U.S. Navy and the Hillsboro Martin J. Ryan V.F.W. Post #2666.

Reverend Richard K. "Dick" Colsen was born July 19, 1927 in Dove Creek, Colorado, the son of the late Albin Colsen and Jenny (Lord) Colsen. As a young boy, he moved with his family to Oregon, settling in the Vernonia community, where he was raised and received his education, then later with his family moved to Hillsboro where he graduated from Hillsboro High School Class of 1945.

He was a Veteran of World War II, having served one enlistment in the United States Navy, until he received his honorable discharge.

Dick was united in marriage to Florence Mae Colsen on October 5, 1952 in Loveland, Colorado. Shortly after they began their traveling evangelistic work. In the late 1950s,

they moved to Oregon, settling in the Forest Grove community, where he served as the pastor at the Assembly of God Church. They later lived in the Cornelius community, until 1980 when they moved to their home in the Hillsboro community, where he had resided since.

He was preceded in death by his wife, Florence, on March 27, 2011, after celebrating over 59 years of marriage together.

Dick and his wife Florence were instrumental in starting the Valley Full Gospel Church in Hillsboro, where they served for over 45 years, until they retired.

Among his special interests, he enjoyed fishing with his son, David, especially trout, steelhead, and salmon.

He was also preceded in death by his parents, Albin and Jenny Colsen; his brother Harry, and his two sisters, Lucille and Rene.
