### HIGHWAY COMMISSION GETS BUSY ON BIDS FOR BRIDGE

J. M. Devers, attorney for the  
state highway commission, was in  
Eugene Friday for the purpose of  
obtaining the signatures of the  
members of the Lane county court  
to the contract with the state and  
Lane county for the erection of the  
Pacific highway bridge across the  
Willamette river at Harrisburg.

Mr. Devers said that bids for the  
construction of the span and long  
approach will be opened within a  
few days and it is expected that  
the structure will be ready for use  
early next summer.

A slight change will have to be  
made in the right of way of the  
highway near the Lane county end  
of the bridge, Mr. Devers said. This  
will be graded this year, the grade  
allowed to settle and the entire  
stretch between the bridge and  
Junction City will be paved next  
year.

Lane county voted at the election  
May 16 to levy a two-mill tax as  
Lane county's share of the cost of  
the bridge. Lane county had al-  
ready voted bonds to pay for its  
one-third share of the cost.
