The purchase price, with an additional sum of one-fifth of 1 per cent thereof, being commissions allowed, must be deposited at time of sale, money to be returned if sale is not approved, otherwise patent will issue for the timber which must be removed within ten years. Bids will be received from citizens of the United States, associations of such citizens and corporations organized under the laws of the United States, or any State, Territory, or District thereof only. Upon application of a qualified purchaser, the timber on any legal subdivision will be offered separately before being included in any offer of a larger unit.

LANE PRISONER CONFESSES TO UNKNOWN KILLING

C. R. Moore, on Way from Iowa With Deputy, Puts Latter in Denver Hospital.

Denver, Colo., Oct. 16.—C. R. Moore, held in jail here, confessed today, the police say, that he killed a man in Portland, Oregon, 18 months ago while attempting to hold up a man and a woman in an automobile.

Moore, also known as White, has been in jail here since last Sunday, following an attack on Deputy Van Sawyer, of Eugene, Oregon, Sunday, near Sterling, Colorado, while the deputy was returning the prisoner by automobile to Eugene. "The man grabbed my gun," Moore is reported to have confessed. "I fired and the bullet went wild. I shot again and the fellow crumpled up in the back seat. The woman became hysterical and began screaming. I didn't wait to search them for money and valuables but ran from the scene. I didn't know I killed the man until I saw the newspapers the next day."

Portland, Ore., October 16.—Portland police said they had no record of any crime such as that reported to have been confessed to by C. R. Moore at Denver. They said, however, that the confession may relate to some crime in this vicinity. About a year and a half ago a man was found slain on the Columbia river highway between Portland and Hood River and no identification of the victim nor clue has been reported.

Moore has now arrived at the Lane county jail. Before leaving Denver he confessed to a number of other alleged crimes from under duress to holdups. One murder was supposed to have been committed near Eugene.

Sheriff Taylor is of the opinion that most of his confessions are fairly tales, although Moore has a long crime record.

TARIFF STAND OF LA FOLLETTE UNFAIR

Products of Wisconsin Only Ones He Showed Any Interest In.

Portland, Or.—(Special)—The La Follette record on the tariff, it has been pointed out here by the Republican State Central committee after an inquiry, has been thoroughly inconsistent and thoroughly selfish.

La Follette voted for the highest tariff rates on all products of his own state and for the lowest rates or no tariff at all on everything produced elsewhere.

He voted for the highest duty proposed on linseed oil and flax-seed oil, both made from raw material produced in his own state. He was so insistent on protecting the Wisconsin product that he voted amendment of the committee report submitting the Fordney-McCumber schedule, inserting a new paragraph providing a tariff on casein, and he voted to amend the report by increasing duties on honey, poultry, cream and a number of other products of vital interest to the state of Wisconsin. But he voted, on the other hand, to decrease the duty on almonds, walnuts, rice, nuts, lumber, shingles, etc.

Because of his bitter opposition to a tariff on woolen textiles he was afraid to vote for a tariff on wool. On the other hand, because the sheep-raising industry is well established in his state, he was afraid to vote against the tariff on wool so he was absent on all roll calls on the wool schedule.

La Follette consistently voted against the tariff on all manufactured goods with two exceptions, metal pants buttons and metal hooks and eyes. In both these instances he voted to increase the schedule above the committee report. It was not understood why he was so careful of the welfare of manufacturers of these articles.

POSTAL BILL VETO IS EASILY EXPLAINED

Portland, Or.—(Special).—There has been plenty of criticism of President Coolidge because of his failure to approve the bill to increase salaries of letter carriers and postal clerks, but, according to the Republican State Central committee headquarters here this adverse comment comes from persons not familiar with the facts.

The committee points out that two measures for relief of the underpaid postal workers were considered, one that had the approval of the administration and was recommended by Postmaster General New. Mr. New, moreover, is the only postmaster general who has ever proposed higher pay for all postal workers.

The administration measure carried an expenditure of \$48,000,000 and would have been signed by the president had it passed. But the postal employees stood out for their own bill appropriating \$68,000,000 and, unlike the other, providing no means of meeting this added expenditure.

It was that bill the president vetoed, his reason being that the measure did not provide for the proposed expenditure and he was compelled to give it his disapproval. His action, viewed in connection with the administration bill for the relief of postal employees did not show him out of sympathy with the needs of the postoffice workers.

CITIZEN AWAY FROM HOME MAY CAST VOTE

Oregonians may vote even if away from their own precincts on election day. It is pointed out by the Republican State Central committee. There is a provision in the election laws that will permit this practice, so that those need leave their homes November 4.

Because of the livestock show at Portland closing just before election day, it is thought a number of persons may not return home in time to vote and the way this can be accomplished is pointed out.

Anyone who expects to be at a distance from home on election day should provide himself with a certificate of registration that he may obtain from his county clerk. By presenting this certificate, he will be entitled to vote in any county of the state for state and national tickets.

In case the absent voter has not obtained a certificate, it will be required that he swear in his vote. This can be done in Multnomah county by six freeholders, but in other parts of the state, two freeholders may make affidavit.

Motion Pictures of Lips Aid the Deaf to Speak

By means of motion pictures of the lips of a person speaking, the deaf, children with defective speech, and foreigners are greatly assisted in their



efforts to talk correctly and to interpret sounds by lip-reading. A specially devised camera takes a series of "close-ups," the "model" pronouncing the words, taking great care to move his lips in the precise positions for forming the sounds. The pictures are shown with the words and symbols to accompany them, supplying a graphic "pattern" for the pupils to follow.
