EARLY EVENTS RECALLED BY OLD TIME TEACHER

drifted up to Woolley that his favorite candidate had carried the country.
The temptation to celebrate was so great he could not resist it, so bending over to see the ground he waved his hand as best he could without losing his balance and, with a voice that sounded as though he was afraid the slightest emission of breath would dislodge him from his perch, exclaimed in what was meant to be a shout but in reality was merely a hoarse whisper which could scarcely be heard to the ground, "Hurrah for Cleveland!"
The sight was too much for those gathered below and they dashed into the building and out of sight that they might enjoy a laugh unnoticed by the man above.
The first school house in Cottage Grove was located in a low frame structure on the bank of the river near what is now Adams avenue. After the next building was erected this first structure was sold to Cochran and Martin who moved it to the present location of Compton and Burkholder and used it as a furniture store.
Mr. Veatch has records of the class work done in the Cottage Grove schools during the years 1899 and 1900 and the class records of many persons now living, some of them still in Cottage Grove, are contained in these old books. When Mr. Veatch was on the school board he kept a complete record of the grades of each pupil so that the youngsters could come to him at the end of the month and find out their standing as

well as they could from the teacher. By this method the directors were able to keep close tab, not only on the pupils, but on the teachers as well. It would sometimes happen that grades from one room as turned in by its teacher would be remarkably good. When that happened the board would immediately become suspicious for Mr. Veatch knew from his own teaching experience that all the children couldn't be entitled to high grades. Many teachers lost their positions by trying to impress the board with the good grades of the children under them.
Among those who were attending school at that time were Edgar Newcomb who now lives near Rattlesnake, on the other side of Pleasant Hill; Ruby Thomas, who married Tom Medley and now lives in California; Lizzie Knox, who married C. D. Price and is now living in San Francisco; Ethel Knowlton who now lives near Portland; Estella Martin, of Klamath Falls; Lillian Hart, now Mrs. Harry Wheeler living in Roseburg; and Damon Sherwood now in California. Damon Sherwood's father, Perry Sherwood, was postmaster in Cottage Grove for a number of years.
John Veatch, now a Portland attorney, was a student here in 1899. He has recently been appointed to fill the place on the Fish and Game Commission vacated by Dr. Ross.
J. F. Holland was principal of the school then and was commonly known as "Professor", by the students. There were three grades above the eighth giving work in arithmetic, algebra, Latin, history, physical geography, grammar and English rhetoric, physics and a few other subjects. Professor Holland was inclined to use the rod sparingly and this kept the board from hiring him for a second year. O. F. Knox was then a member of the school board and one of his boys had a round with the professor and received a thorough whipping from him. Knox was angry at this and it was through his influence that the professor was dropped.
In the spring of 1900 the eighth A grade consisted of the following pupils: Blanche Johnson, Ethel Knowlton, Estella Martin, Katie Bennett, Ruba Thomas, Lizzie Knox, Herbert Hawley. These were all promoted to the ninth. Those who left school before examination and were not promoted were: Orpha Hawley, Charles McKibben, Ethel Stroud, Irene Condon and Edgar Newcomb.
Those of the eighth B who were

promoted to the eighth A were: Rolice Baker, Ethel Woolley, Clara Van Riper, Mabel Thornton, Dolie Hawkins, Greta Bristow, Minor Allen, Charley Hambric, Myrtle Rhodes, Etta Spong and George Berry.
Those promoted in the seventh A class were: Oliver Elsen, Maggie Gaugh, Emma Rhodes, Laura Landess, Eddie Finerty, Menzor Finerty, Edna Hambric, Leta Sanford, Jimmie Harris, and Cora Van Fleet. Willie Orrell left school before examination and was not promoted that year.
In those days schools were as proud of their literary societies as those of today are of their football teams. The Athenian literary society of the Cottage Grove high school elected Duke Knox, president; Elbert Veatch, vice president; Lewis Spong, secretary-treasurer and Professor Holland critic on February 3, 1900, according to a news story in the Bohemia Nugget of February 10, of that year.
The program given by the society on Friday, February 10, 1900, was: 1. Response to roll call by quotations from some good author. 2. Song by society. 3. Recitation, Roy Hemenway. 4. Composition on education, Ezra Baker. 5. Talk on Temperance, Elbert Veatch. 6. Song by society. 7. Debate: Resolved, that Samson should have more glory than Schley for the naval battle of Santiago. The affirmative side of the question was taken by Samuel Bennett, Elbert Veatch, Ida Thomas, Neva Perkins, and Horace Harms, while the negative was upheld by Cris Jackson, John Walden, Lewis Spong, George Walden, and Noa Sherwood.
In the winter of 1899-1900 the school consisted of five rooms and had about 246 students enrolled. The honor roll of the school as published in the March 3 edition of the Bohemia Nugget was:

Few would recognize the Cottage Grove of a few years ago as shown in a picture postal card which has been handed The Sentinel by J. L. Beatty. The card was mailed to Mr. Beatty from Saginaw while Mr. Beatty was filling a pulpit at Lebanon. The postmark was "April 3, 1908," but the picture had been taken some time before that.
It was taken looking west from what is now the intersection of Sixth and Main streets. The south side of the street was built up entirely with frame buildings, every one of which has since disappeared. Not even the building occupied by Burkholder and Compton, the oldest building now standing in that block, had yet been erected. The corner on which that building now stands seems to have been vacant at the time the picture was taken. On the north side of the street appears the old Oregon hotel building, which was razed two years ago and the Kem building erected in its place. The lot next to this building on the west was vacant and next to the vacant lot was the Stewart brick, which still stands. At the Fifth street corner were frame buildings which have since been replaced by the old Arcade building and the Churchill building. The Lureh building, the Griffin & Veatch building and the Methodist church, all yet standing, are plainly visible. The Alta King law office, since removed, stands at what appears to be the west end of the street and to the south of the old bridge which can not be seen in the picture. The King building was removed several years ago and part of the new bridge covers the ground once occupied by the King building.
