CHAMBERS ROAD WILL COME TO COTTAGE GROVE

Sufficient Number of Options Are Signed by Property Holders to Assure Project.

Sufficient options on property for the right of way for the ten miles of railroad which will be built from the proposed new Chambers mill to Cottage Grove have been secured to make it practically certain that the road will be built through here, and that the work will go ahead as planned, according to J. H. Chambers.

As a result of the activity of the commercial club in interviewing property holders in connection with the right of way satisfactory arrangements have been made with all but three or four land owners. Unless an agreement can be reached within the next few days with these men, condemnation proceedings will be started and the matter settled that way.

While no definite date could be given as to when construction work would start it is likely that it will be in the near future. The first shipment of rails for the new road is expected in February and the matter of the right of way must be settled by the time they arrive. Had it been decided to take the lumber out by Curtin the rails would have been sent there instead of being unloaded at Cottage Grove.

Mr. Chambers spent Tuesday of this week in Eugene investigating the possibilities of bringing condemnation proceedings against the property on which he has not secured options, should this become necessary.

Hand Hurt Wrestling at Crescent City

Ralph Hand, local wrestler, was hurt in the wrestling contest in Crescent City last Saturday night when he and his opponent, Gus Schnidow, fell through the ropes and onto the floor after the contest had lasted 40 minutes. Hand lit on the floor with Schnidow on top of him and was hurt in the small of the back so that he was unable to go on with the match.

The accident happened when Hand had a wrist lock on his opponent and Schnidow was struggling to get a croch hold. The two fell onto the ropes which broke and let them fall on the floor. It was called a "no match" event as Schnidow refused to take the decision when Hand, due to his injury, would not continue the contest.

The injury to the Cottage Grove wrestler was not serious and he is practically all right now.

Hundred Members Goal of Legion Post in Drive

Thirty-Eight Arrested in City During Past Year

Out of 38 arrests in Cottage Grove during 1924, 13 were for violations of the liquor laws and 22 for traffic violations, according to the report of Chief of Police G. B. Pitcher submitted at the council meeting Monday evening. Fines for liquor law violations amounted to \$175 and \$107 was collected for violations of the traffic laws according to the city recorder's report submitted at the same meeting.

The police report shows that 5864 feet of walk was constructed in the city during the past year. Of this 3432 feet was of cement, 1946 board and 484 feet cross walks. During the year the council passed 25 ordinances and authorized two bond issues.

Local O. A. C. Students on Rifle Team

REPORT SHOWS SALARIES PAID COUNTY TEACHERS

Divisions of salaries in Lane are as follows: Those receiving \$800 to \$900—39; \$900 to \$1100—22; \$1100 up—57. Rural schools: \$600 to \$800—107; \$800 to \$900—30; \$900 to \$1100—32; \$1100 up—1.

EUGENE ATTORNEY TO COACH UNIVERSITY ELEVEN

Richard Shore Smith, Former Oregon Player, Takes Place Left By Joe Maddock.

UNIVERSITY OF OREGON, Eugene, Jan. 22.—Richard Shore Smith, of Eugene, former all-American fullback and all-around athlete and during his playing days captain of two collegiate elevens, Oregon and Columbia University, New York, was elected coach of the University of Oregon eleven to succeed Joseph H. Maddock, resigned, at a meeting of the executive council Wednesday.

Smith won the distinction of making the all-American team while a law student at Columbia, following his graduation from the University of Oregon in 1901. He played on Columbia elevens from 1901 to 1903. With the appointment of Smith, there are now two former all-American players holding coaching positions on the Pacific Coast. Andy Smith of California, while fullback on the Pennsylvania eleven, won the honor. The two Smiths competed against each other when Columbia met Pennsylvania in 1902.

The new Oregon coach, known to his friends as "Dick," has followed football since his college days. He coached the Oregon football team in 1903 after completing his law course in the East, and in 1904 returned to New York to tutor the Columbia eleven for a year. In recent years he has aided the Oregon coaches, giving a good deal of service to the squad last fall when Maddock was head coach.

Smith played on Oregon elevens from 1896 to 1901, the last two years as captain. He played on an Oregon eleven that won from a University of California team 2 to 0, a remarkable achievement for the young Eugene institution. He made his "O" also in track, competing in the broad jump and the weights. While at Columbia the Oregon man starred in track and crew as well as in football. The Columbia football captaincy came to him in his third and last year on the Eastern eleven.

After serving a year as coach at Columbia, Smith took up the practice of law in Oregon, locating first at Astoria and later at Klamath Falls. Some years later he moved to Eugene, where he practiced since. His firm is Smith and Bryson.

No details of Smith's contract or salary were announced by the executive council today. The new coach will have charge of spring practice.

Purchase of Flusher is Considered by Council

The question of purchasing a horse drawn flusher for use in cleaning the streets, from the city of Portland, was discussed at some length at the meeting of the city council Monday evening. Portland has recently installed motor equipment for its street cleaning work and consequently has a number of horse drawn flushers for sale. At a meeting of the council some time ago the expenditure of \$125 was authorized for the purchase of this equipment.

The report of the city recorder and of the treasurer were submitted at the Monday night meeting and referred to Grant Tower to be audited.

The matter of improvement of Quincy avenue, which construction work on the O. P. & E. has left in poor shape for some time, was referred to the street committee.

The suggestion was made that this section of the street should be planked as the best means of improving it. An effort will be made to make arrangements with the railroad to have this work done.

The question of opening Third street was brought up before the meeting and discussed at great length but no decision was reached in the matter.

The scenery and stage settings for the production have been prepared by Ren Sanford at a great expenditure of time and energy. Ruth Stewart has charge of the musical part of the program.

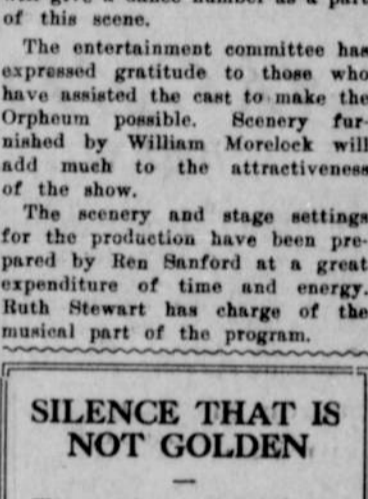

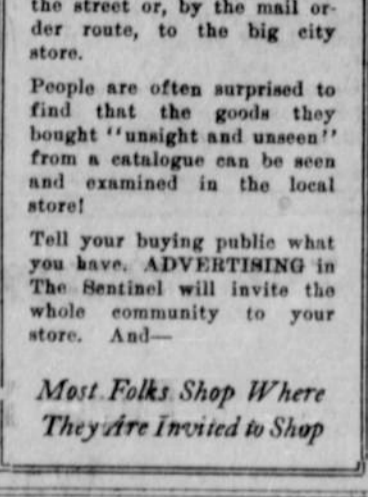
