LANE COUNTY FINES LOW FOR LIQUOR VIOLATIONS

Lane county collected in fines by the state prohibition department \$8,792.50 during the past year according to the state report showing the amount collected by the various counties just issued. The county is listed 11th according to amount of money collected.

The total amount of fines in the state was \$6,408.40 in 1923, less than the amount collected in Lane county this year. Coos county headed the list this year with \$22,000 in fines collected through the efforts of prohibition officers.
