Legislative Sidelights

STATE CAPITOL, Salem, Ore.,
Jan. 29.—(Special.)—Representative
A. R. Hunter, one of the few dem-
ocrats that ever got a chance to
come to Salem, and who is sane
and sensible enough and good na-
tured enough to be a republican,
repeated one of his famous speeches
in the house today. He is a man
of few words and the time he
likes to say something is when the
republicans have presented an
economy measure which he can
support. Coffey's bill No. 62, to
make voting easier, was up for
the third passage. Hunter's speech
was, "This is a good bill. It is
in the interest of democratic econ-
omy, democratic simplicity and the
democratic party and should pass."
He has several times gotten a
good laugh on his speech and it
always takes well.

A number of the members have
their wives with them, ostensibly
to give them a vacation but prob-
ably to get a chance to dictate to
them and to tell them what to do.
Also probably so that said wives
will come to the realization that
their husbands are really as impor-
tant in the affairs of state as they
have tried to make their wives be-
lieve.

The oldest member of the house
is Representative Fitzmaurice, of
Gilliam, Sherman and Wheeler, who
is aged 67 and could easily be
grandfather to the kids of the
house, Representative Bates of Clatsop
and Representative King, of
Columbia, both of whom are within a
few days of the same age, which is
22 years.

Despite the fact that Representa-
tive Charles Hunter, of Union and
Wallowa, is a republican, while his
brother, A. R. Hunter, of Union,
is a democrat, both get along with-
out any ruction, possibly because
both are men of few words. I
have yet to hear the Hunter of
Union and Wallowa make a speech
on the floor, although it is said
that he is a good speaker upon
occasion. The Hunter of Union
broke the record with two speeches
of about 25 words each on the
floor Thursday. Public service
seems to run in the family. The
father of the two, William G.
Hunter, served upon the state
equalization board a number of
years ago, while the father of
William G., whose name also was
William, served in the legislature
back in the 60's.

Senator Charles Hall, of Coos,
and Representative Hall of Colum-
bia, are brothers. The senator is
in the telephone business, while the
representative formerly was in that
business. The senator, of course,
is well and favorably known
throughout the state and may be a
candidate for governor. When
Representative Hall was asked
whether he was any relation to the
senator, he facetiously replied
that he was merely a long distance
brother.

Former Representative Woodson
and Former Representative Egbert,
the latter representing the Farmers'
Union, have been here for several
days looking after legislation in
the interests of the eastern Oregon
farmers who lost their seed wheat
in the recent freeze.

SOLDIERS' LETTERS TELL
OF PHILIPPINE CONFLICT

and joking with the boys. He
said they were about to move him
on board the hospital boat Relief
which will soon come to San Fran-
cisco. I was with him a minute
after he was hit and stood with
him as long as I could. He was
hit while his company was charging
over a small ridge. The natives
were on the high hills on both
sides of us but did not last long,
as usual.

"Elmer Doolittle was shot
through the right arm, about five
inches from the shoulder, by a
Mauser bullet. He is getting along
fine, and is on board the Newport.
The rest of the Cottage Grove boys
are all well."

A clipping from the Palo Alto,
California, Times, quoted in the
Bohemia Nugget for Friday, August
23, 1899, reads: "Mr. Elmer Doo-

little of Cottage Grove, Oregon, a
member of the 2nd Oregon Volun-
teers, has been visiting his cousin,
Mrs. Edward Aekley. He is away
on sick leave, having received a
Filipino bullet through his right
arm and leg. Mr. Doolittle comes
of fighting stock, his father and
forefathers all having been among
the first volunteers to fight in our
past wars."

Other letters from the islands
toll of Mr. Doolittle being wounded
in the arm but do not mention
the wound in the leg.
On Friday, May 12, the Nugget
contained the following item:
"William Landess is in receipt of
a letter from Henry at Manila
which states that he is quite well,
that they have seen considerable
fighting, and that they are still
living in expectation of getting
home before a great while. He
also states that Frank Woodruff,
who was recently wounded in the
heel, is able to walk around."

In a letter written to Henry
Lineo on December 21, 1898,
Frank Woodruff, of Company C of
the 2nd Oregon volunteers gives
the following description of the
quarters of the Oregon troops in
Manila.
"One company of the Oregonians
are at the palace and another at
the custom house. The rest of the
regiment is in the barracks that
formerly were occupied by the
Spanish army. We do duty inside
the city. The Filipinos are steal-
ing powder all the time and the
guards have been doubled. We
were ordered to fill our belts with
cartridges and have our guns ready
as there was an insurgent scare,
but nothing came of it. We heard
today that the insurgents had or-
dered the Americans to evacuate a
block house and the First Califor-
nia were sent out and the insur-
gents consented to withdraw but
we may have trouble yet.

"Charlie Lovelace is about to
be appointed corporal and I think
he will get it all right. We have
dress parade three times a week
and we put up as good a one as
any regiment here. The Oregon
baseball team is holding its own.
We recruits expect to get paid in
a few days. This is a free silver
country; a half bushel of money
here is only worth a couple of
American dollars."

The Oregon boys came very close
to winning the baseball champion-
ship of the army in the Philippines.
A letter from Henry Landess tells
of a game in which the Oregon
team won from the 13th Minnesota
regiment by a score of 9 to 4.
The letter stated the Oregon boys
had the best record there and
had only the 19th Pennsylvania
team to beat in order to get the
championship.

A soldier from Dakota describes
the contact which the American
soldiers kept with the natives in
the following paragraph from a
letter published in the Nugget.
"The natives do a big business
with our boys on credit and often
times we are loser to a great ex-
tent. If an American has no
money he goes to a native's house
and helps himself to what he
wants, writes it on a piece of
paper, tells the native he will have
mucha dinero polka tempo and
any time within a month. Rice is
the native's chief food. The pick-
aninies hang around our quarters
and gather up everything we leave
after a meal."

Charlie Cochran writes the fol-
lowing description of the fighting
around Santiago:
"On the 1st of July the 1st In-
fantry supported by light battery
"E" 1st Artillery demolished the
fort at El Caney. There being no
return fire we passed the day in
looking over the field of battle
and saw the charge on the fort
which they took about 4:30 p. m.,
then the artillery pulled up and
we all joined the rest of the troops
near the town, which was captured
soon after. This division (2nd)
then marched three or four miles
down the road toward San Juan
where another division of the army
had been fighting that day and
camped. The next morning the
artillery and this regiment marched
back over the same road past El
Caney by a round about way of
about eight or ten miles and took
a position near the El Posa fort
about noon to open fire on San
Juan, but for some reason they
did not do so.

"The fort and Spanish trenches
were taken that afternoon and the
Spaniards withdrew into Santiago
a mile or so to the west. There
no more fighting was done until
July 10 at 4:20 p. m., when we
had Santiago surrounded and com-
menced bombarding the city. Then
was the time the 1st Infantry was
in some danger. We were lying
in the rear of a battery of artillery
which the Spanish artillery was
firing at and the bombs would
burst over and all around us but
only one man was struck, and a
horse killed near us. The next
day a flag of truce was raised
and there was no more fighting.
The city surrendered on July 14."
