Generous Share Of Federal Money To Be Given Oregon

Nearly \$1,250,000 Allotted For Forest Roads and Trails During Fiscal Year.

State Received Nearly One-Eighth of Appropriation For All Country.

Oregon will get the benefit of nearly \$1,250,000 of federal money for forest roads and trails during the fiscal year of 1926, according to word received at the offices of the United States forest service in Eugene.

The total road and trail appropriation, amounting to \$1,243,805, is divided into four funds, giving a direct appropriation by congress to Oregon, according to the forest officials. With the addition of \$163,802 from the 25 per cent road and school fund, a grand total in these funds alone of \$1,412,607 will be spent by the forest service in Oregon as compared with \$675,216 garnered last year by the government from sales of timber, grazing fees and other sources from the 14 national forests in the state.

Oregon has received nearly one-eighth of the total appropriation for the entire country since the road and trail funds were established, according to the report, a grand total of \$7,755,490 having been given to this state. Thirty two states have participated in the distribution, with Oregon ranking second.

The driver of the car, probably fearing that he would be charged with a violation of the game laws, hurried on, but two members of the Kappa Sigma fraternity of the University of Oregon, passing soon afterward, picked up the carcass and took it to Eugene, where a deputy game warden was informed. He gave permission to the boys to serve the venison for Thanksgiving dinner.

W. R. Lloyd Hanged At State Pen Today

No Friend or Relative Appears At Trial of Former Resident Here.

Salem, Ore., Nov. 25.— Notices of the execution of W. R. Lloyd Monday morning at 10 o'clock were mailed today at the penitentiary. Lloyd was convicted of killing Clint I. Bann, Independence taxi driver, the night of September 1. Lloyd's Thanksgiving dinner will consist of the "main line" menu served other prisoners and includes roast chicken, two kinds of cake and the accompanying "trimmings."

W. R. Lloyd was a resident of Cottage Grove up to within a short time before the murder for which he has been hanged was committed. A week or so before he murdered the Independence taxi driver, he had been out with a taxi driver here.

Lloyd was without funds for his defense and no friend or relative appeared at the trial, nor was he visited by relatives while he awaited the gallows. His parents, who were residents here up to within a short time of the murder, are living elsewhere, their whereabouts being unknown here.

Men Spend Night In Search for Dogs

Marion and Delmas Richmond and their guest, Walter Jones, who were here from the University of Oregon for the Thanksgiving vacation, spent Friday and Saturday at the Richmond-Durham cabin on the Sharns creek road into the Bohemia district. Marion assisted Jack Klopfenstein, a miner, in a search for two hounds which had become lost. They traveled on horseback through snow two feet deep for a large part of the night, finally finding the dogs, one at the Musick mine, and one elsewhere. The dogs had been gone 10 days and were emaciated from lack of food. On account of the snow, night in the district is about as light as day.

LOCAL SCENERY MAY BE USED BY FILM COMPANY

Eugene is to become at once headquarters for the Cope Film company, which has secured a 30-acre tract southwest of that city and will make an initial investment of \$100,000. The production of films will start at once. It is probable that Cottage Grove scenery will be used from time to time, as the manager of the company has announced that the scenery desired is to be found within a radius of 40 miles of Eugene.

No One Interested In City Tax Levy

Only One in Audience When Council Appropriates \$23,459 for Year.

Cottage Grove's city budget, carrying items totaling \$23,529 was adopted Monday night by the city council, without a member of the citizens' budget committee being present, with one alderman absent and with only one private citizen present and he a regular attendant at council meetings. The amount is practically \$1,500 less than the budget of a year ago. With the assessed valuation of the city raised during the past year by the assessor, the millage will be considerably lower than a year ago.

The items in the budget are \$10,419 for the general fund, with esti-

imated receipts of \$1,200; \$3,450 in the sewer fund, \$3,000 of which is for interest and sinking fund; \$5,950 in the street fund, \$3,000 of which is for interest and sinking fund; \$5,950 in the street fund, \$1,500 of which is for bonded indebtedness, with estimated receipts of \$2,000; \$600 in the library fund; \$500 for the park fund; \$1,000 for the emergency fund, and \$2,810 for the bond and warrant interest fund.

The expenditures of the water fund are cared for entirely by receipts, including the retirement of bonds and all funds are in first class condition.

Work on Railway Is Halted by Weather

J. H. Chambers May Convert Gravel Pit Into a Log Pond for Mill.

On account of the excessively moist weather condition, J. H. Chambers has had to discontinue construction work on his railway to timber west of here. Some contract work is being continued. Work in the yards south of the city, where gravel for ballast is being dug, is being continued. Five miles of track have been ballasted, between 10,000 and 12,000 yards of gravel having been used.

The digging of the gravel may serve a double purpose, for a pit remains that can be easily converted into a log pond in case Mr. Chambers decides to locate his mill at this end of the railway, instead of in the woods. If it is found that the gravel pit will hold water, it is quite likely that the mill will be set here. Water for use in the pond can be taken at little expense from the Coast fork, which skirts the property. It is probable that there might at first be some difficulty in getting water to stay in the pond, but it is more than likely that the dirt and debris that would soon accumulate would act to cork the leaks. The pond would have a hard pan bottom.

MRS. ULYSSES S. MARTIN DIES AT SEATTLE, WASH.

Husband Was Business Man Here Several Years Ago.

Mrs. Emma Jane Cox Martin, former resident of Cottage Grove, died November 19 in Seattle at the home of a daughter, Mrs. W. W. Robinson. Funeral services were held in Seattle November 21.

Mrs. Martin was the wife of Ulysses S. Martin, former business man of this city. He and B. K. Lawson were once in the furniture business here. She was a daughter of Mr. and Mrs. William Cox, early pioneers of the state who came here from Missouri. Mrs. Martin was born June 2, 1867, at McMinville and married Mr. Martin in 1882 at Pendleton. They came here in 1890 and resided here until moving to Seattle in 1905. She lived there and at Yakima until her death. She was for 41 years a member of the Christian church.

The husband and following children survived Mrs. W. W. Robinson, William F. Martin, Mrs. C. H. Morrow and Miss Alice Martin, all of Seattle, and C. C. Martin of Yakima. There are 10 grandchildren. Surviving sister and brothers are Mrs. Perry Pearson, Clarkston, Wash.; Oliver J. Cox, Heppner, Ore.; and James Cox, Clarkston, Wash.

Not an Arrest Made On Turkey Day

Annexation Election Is Called for Jan. 4

Water and Light Service And Rate Reduction to Follow Favorable Result.

A special annexation election will be held here January 4 to act upon the petition of property owners to the north and to the south to come into the city. There will be one polling place in the property to the north of the city, another in the property to the south of the city and one in each ward in the city.

In case the election results favorably to annexation, the property added to the city will be immediately granted city water service and fire protection, as well as street lighting. Those in the outside territory now getting water will get their water at a third less than they are now paying, and will save even more, as rates to outside consumers are to be given another boost shortly.

MARKET ROAD MONEY ALLOTMENTS FINISHED

Disston District to Get \$5,000 Of Funds, Lynx Hollow \$2,000.

Agreement has been reached by the county court and budget committee on allotments of the county road market funds for the coming year. Although final action will not be taken on some of these until certain amounts are raised in the respective districts. The maintenance fund has been cut from \$40,000 to \$30,000, which leaves approximately \$70,000 for new construction on market roads. The distribution of the \$70,000 as tentatively agreed by the court and committee is as follows: Deadwood, \$3,000; Poedie creek, \$1,500; Noti west, \$9,000; Disston, \$5,000; Horton pontoon, \$5,000; Fox Hollow, \$3,000; Lynx Hollow, \$2,000; McCallum Gap, \$9,000; Perkins road, \$6,500; Mapleton-Cushman, \$5,000; Crow-Vaughn, \$20,000.

CONTRACTOR TURNS IN WARRANTS AND LEAVES

Nothing Heard of George W. Read After He Assigns Assets.

The whereabouts of George W. Read, contractor who was reported to have left Eugene after cashing some \$14,000 of municipal warrants prematurely delivered to him, remain a secret. Mr. Read's attorney has stated that his client left that city November 14 after assigning his assets to his creditors. He expected to be gone about three weeks, the attorney said.

Delivery of the warrants to Mr. Read was the cause of considerable criticism of certain Eugene city officials and lead to the resignation of Mayor E. B. Parks. No action has been taken against any of the city officials.

An Oregon bonding company is liable for \$37,122.82 for labor and material bills contracted by Mr. Read. The largest single creditor is the Oregon Portland Cement company with a claim of \$31,530. Other claims total \$64,463.83.
