EUGENE'S RAILWAY MAP.

A splendid souvenir edition of the Eugene Register, issued as a boost for the trail to rail celebration, arrived here today. It is a splendid piece of editorial work and a splendid piece of printing and it is regrettable that it is necessary to offer a word of adverse criticism.

One of the illustrations is a map showing the Eugene-Klamath Falls cut-off. If the map had been confined to this, all might have been well, but the main line of the Southern Pacific is also shown and the first point south of Eugene shown on the map is Divide, four miles south of here, where the railway does not so much as maintain a station agent, while Cottage Grove, the second largest city of the county and a more important shipping point than Eugene, is conspicuous by its absence.

Drain, a town of 400 or 500 is on the map, as is also the little station of Rice Hill, which is little more than a jumping off place.

Although the souvenir edition of the Register arrived here but a few hours ago the omission of Cottage Grove from the map has been called to the attention of The

Sentinel by several business men. The appearance on the map of points at which trains do not even stop, one of them only four miles from an important city like Cottage Grove, makes the omission so glaring that it seems a studied slap at our city. Eugene is not yet so far on the road to prosperity that it can afford to purposely and repeatedly affront its neighbors.

Quite in contrast to this treatment by the Register was a splendid story of Cottage Grove's potential resources which appeared in the Eugene Guard's trail to rail edition.

The Eugene Guard has taken advantage of the trail to rail celebration to issue a 32-page illustrated special issue in which the resources, scenic advantages and attractive features of Lane county are set out fully.
