TRAFFIC COPS AND PHILOSOPHY.

The Observer in The Telegram expresses the wish that the editor of The Sentinel may philosophically forgive the traffic cop whose painstaking attention to duty resulted in the editor being required to part with two shining brand new car wheels, presumably to be used in repainting the Eugene "Stop" signs such a color that their visibility will be enhanced.

It is easy to philosophize about most things, but the loss of a week's wages for the sake of the few seconds that it would have taken to bring a car to a dead stop requires stoicism as well as a philosophical turn of mind.

However, if there is anyone we can easily and conscientiously forgive and wish him the best of luck it is the traffic cop. We are pleased to note that he has risen so far in the estimation of the public that he is no longer referred to in terms of opprobrium as a "speed" cop.

Our relations with the traffic officers have been most friendly and most cordial. With few exceptions they are gentlemen and we have found their attitude toward the traffic offender far more to be complimented than the attitude of many traffic offenders who carry rear vision mirrors and a complete assortment of alibis in their effort to outwit the only person on the road who is trying to make use of the highways safe for the careful driver.

The two-dollar fine may have been a serious one to a country editor, but it probably is only part of what we might have had to pay had we been apprehended every time that a traffic regulation has been overstepped. Possibly there are one or two others in the state in the same position.

We're for the traffic officer. He is a motor-cycled, khaki-clad angel of the highways. The principal fault we have to find with him is that he doesn't jail the fel-

lows who drive the highways at night with only one light burning or with lights that endanger the lives of those in cars that approach them.

HUGH, HOW COULD YOU?

The Sentinel has for years held up to the public as a bright and scintillating journalistic light and literary fountain of knowledge that entertainingly enjoyable Portland weekly, The Spectator, but we shall have to retract all the complimentary things that have been said about that pabulum of personal liberty and dub it the boob of the press.
