THE UNPARDONABLE SIN.

In a recent issue The Sentinel characterized the unpardonable sin as that of failing to pay a newspaper subscription, but professed ignorance of biblical authority upon which such a statement could be based. Pastor E. O. Colbeck, of the Baptist church, has referred us to the following passage:

But the same servant went out and found one of his fellow servants who owed him and hundred pence and he laid hands on him and took him by the throat, saying, "Pay me that thou owest."—Matt. 18:28.

The Sentinel feels deeply grateful to the dominie for referring it to the place in holy writ where may be found full authority for using the only manner of persuasion that would have much influence on some who are negligent in settling their accounts with the editor.

However, there is another passage in scripture, so we have been told, which says something about letting him who is without sin throw the first stone. As we are solicitous about the welfare of our own neck, despite restrictions as to its uses imposed by law, we shall hesitate to follow the crude methods employed by bill collectors of bible times. Grabbing a fellow by the neck and shaking it out of him may have been all right when newspapers were engraved on stone and there were not more than two or three subscribers to become delinquent, but in these modern days it would take too long to give all delinquents the same treatment.

However, we still maintain that we have correctly named the unpardonable sin and solicit scriptural authority.

UNION OFFICERS COMMENT SENTINEL EDITORIAL.

LORANE, Feb. 2.—(To the Editor.)—I have read with no little interest your leading editorial in the Sentinel of January 30. The president of the local Farmers'

union, R. V. Foster, has asked me to write and express to you his hearty appreciation of your very timely and sensible editorial. I do this the more readily because I feel sure that in cases of this kind you will receive all too few letters commending you for the stand you take, while if you happen to strike an unresponsive chord among your readers you may be deluged with letters reviling you, from "Constant Reader," "Old Subscriber," etc., etc.

Your suggestion for a better arrangement between the town merchant and the farmer is well taken. I am of the opinion that such an understanding can be arrived at and that it will result to the mutual benefit of the merchant and the farmer. Generally speaking, the farmer has learned, by experience, that the city man and the farmer can get along very amicably, if the farmer will just do as the city man wants him to do.

A case in point is that of the city of Eugene passing an ordinance requiring the farmer selling meat there to take out a license and to pay an inspection fee. No doubt the inspection of farm-butchered meat is very desirable, not to say imperative, to properly safeguard the public health, but should the cost be assessed against the farmer? The city merchant buys goods from a jobber and sends his own hired expert buyer to inspect the quality and price of the goods—he does not think of making a charge to the jobber for this service.

There may be farmers who want the government to give them something but I do not agree with them as to the value of any such method. As we progress in civilization, systems in all industries change to accommodate themselves to varied conditions, and so it must, of necessity, be with the farmer, he must industrialize his business to keep pace with advancing times. All the farmer needs and all he can reasonably ask for, to work out his own salvation, is to be given a square deal—this he has not been enjoying to the extent that has been accorded other industries.

AMERICAN MAGAZINE MAKES APOLOGY FOR ERROR.

NEW YORK, Jan. 28.—(To the Editor.)—Letters and telegrams have poured into my office during the past month showing that Multnomah falls, Oregon, is one of the best known and best loved beauty spots in the country. In the January issue of The American Magazine there appeared a picture of this beautiful waterfall with the scene erroneously attributed to California, instead of Oregon. The error was a clerical one in the office of a photographic agency. I deeply regret the misstatement and as opportunity offers in future articles, I shall compensate for it.

A flood of telegrams came first, followed by a deluge of letters which continued in an undiminished stream for four weeks. An expression of our sincere regret was immediately sent to each of the correspondents, when we could reach him, but unfortunately many of the letters and telegrams lacked signature or mailing address and I am therefore taking this means of reaching them.

Naturally some of the protests came from Oregonians, but by no means all of them. Men and women in all sections of the United States wrote in praise of Oregon, using the photograph as the starting point for a great variety of enthusiasm regarding the wonders of the northwest.

Many recalled one of the most notable recent contributions to The American public's knowledge of the northwest—the article published by The American magazine last summer in which Dr. J. Russell Smith, the famous geographer, predicted that the future center of world civilization would be in Oregon and Washington. That article created a tremendous sensation and I am still receiving letters about it, not only from the United States, but from many foreign countries.
