LUMBER OUTLOOK GETS BRIGHTER DAY BY DAY

Car Material Business Is Expected to Put Market Back Where It Belongs.

(Crew's Lumber Index.)

The general outlook continues to grow better every day.

There is little doubt that there will be a bigger footage of west coast woods consumed in 1929 than there has been in the year just closing.

Three outstanding market factors give definite promise of leading the way. In the first place, no one who is informed will question the statement that the coming year will see more car material business than there was in 1928. When car material orders first began to appear, the southern pine mills all ways got the lion's share of the placements. Already the schedules released have given the southern mills such well filled order files that they are no longer in a position to promise quick shipment on many items, and during the past two weeks eastern roads that have not been using fir for some time have placed orders on the Pacific coast, and are free to acknowledge that they will use more fir this year than they have in a long while. In British Columbia the mills that cater to car material business have been busy with orders placed by Canadian railroads, and they cannot handle more business until spring, if not earlier. Add to these conditions the prospect for an increasing volume of car material orders and it will easily be understood why car material prices are advancing rapidly and will in all probability lead other domestic products for the next six months. During normal times many mills do not cater to car material, but past history will show that when prices begin to soar and the difference gets too great over similar grades and sizes in yard stock, more mills are likely to be withdrawn from the normal yard stock production. It does not require any deep study to figure out what such a situation would do to the retail yard market; in fact, it has been forced upon that cause before.

The export market all through the year has been colorless. It has been neither good nor bad. It has lacked just a small bit of momentum to bring prices up several times, but has never been able to get the needed footage for the right time. There are several reasons why there should be more export business in 1929. China is coming into the market again in a heavy way, how heavy, no one can say, but there is a pent up demand in China when the war was on, and it is discouraged new developments, and they use fir in attractive specifications. Australia, which for a time bought nothing, has during the past six months been buying regularly, and that that field will take near to normal footage in 1929 seems a certainty. Add to these prospects the encouraging outlook for more and more business from the east coast of South America, and it will be seen that with the other foreign fields taking their usual volume, the export demand should be big enough to permit the mills to put prices up to where they ought to be before the end of another 30 days.

Then there are numerous reasons, too vague as yet to enumerate here, to cause many to feel that the Atlantic coast cargo market is on the eve of being transformed from a liability to an asset for the Pacific coast lumber industry.

Greater than all of these prospects for a heavier consumption is the frame of mind most of the manufacturers are in on production regulation. Production regulation has been given a real trial and proved beneficial. There will not be the overproduction the first six months of 1929 that there was in 1928, and with these two elements both working to the same end, there should be some money made in manufacturing lumber during the next 12 months.

OREGON WRITER'S VERSE ISSUED IN BOOK FORM

Western writers have increasing ly shown their ability in recent years, but it remained for Ethel Romig Fuller to gain special recognition and prominence by publication of her book of verses, "White Peas and Green." By request of the publishing house, Mrs. Fuller sent manuscripts to Willett, Clark & Colby, Chicago and New York, from which they selected 80 excellent examples of Mrs. Fuller's rhythm. Published in December, it had good demand at the book counters, and has shown ample justification for its publication.

Ethel Romig Fuller has been a contributor for years to eastern magazines, and her verses have appeared often in Sunset Magazine, The Commonwealth, American Mercury, Contemporary Verse, Muse and Mirror, Christian Science Monitor, Youth's Companion, Ladies' Home Journal, and Oregon publications.

The volume itself has a cover and jacket of charm, with absolute originality in design and color. It is set with Garamont type face in titles, the body of the text in clear beauty on an ocre laid book.

Mrs. Fuller has ranged widely for her subjects—hills and valleys, orchards, markets, butterflies, children, birds and aged folk. Perhaps the greatest charm of her work is that she has the spirit of the new verse, retaining the beauty of the older forms.

Boy Forbidden Gun Kills Sister

While playing with a .22 caliber rifle which his parents had forbidden him to handle, Robert Grimes, nine-year-old son of Mr. and Mrs. C. P. Grimes, living several miles west of Junction City, shot and fatally wounded his seven-year-old sister, Mary Margaret, Sunday afternoon.

The little girl had just stepped outside the house when the rifle was fired, the bullet entering the girl's neck and striking a vital spot. She walked to the house about 45 yards distant and died soon afterward.

Coroner Brunstetter, who made an investigation, said the shooting was purely accidental. The boy picked up the rifle and pulled the trigger without pointing the piece at anything, and the little girl happened to be in the course of the bullet.

The boy was almost heartbroken over what he had unintentionally done and the entire family is grief stricken.

NEW MEN ARE FOUND IN LANE COUNTY JOBS

Not a Familiar Face Remains in Either Sheriff's or District Attorney's Office.

Monday was moving day at the county court house and by the end of the day many familiar faces had gone and new faces had taken their places. The most noticeable change is in the sheriff's office, where an entirely new personnel has been appointed by Sheriff Harry Bown, who succeeded Frank E. Taylor. His appointments are as follows:

Julian Strait, criminal deputy; J. E. Carille, criminal deputy; Lloyd Howe, chief tax collector; Elmer Hoidal, assistant tax collector; Thomas Bailey, jailer and process server, and Frank Reid, civil deputy and office clerk.

In the district attorney's office, also there was a complete change. Alta King succeeded John S. Mallory as prosecutor and Eugene V. Slattery succeeded L. E. Ray as assistant. Gordon S. Wells, former assistant district attorney, will assist in the office for several months, his salary to be paid by the district attorney and not to be a charge against the county.

O. E. Crowe, former county commissioner, succeeded M. H. Anderson of this city, who was appointed to the position two years ago when Mr. Crowe, now law firm commissioner, resigned the position because of inadequacy of salary.

Sheriff Harry Bown, who has held the position before, and who first took the job 25 years ago, was visited during the day by a group of the friends who persuaded him to be a candidate for the position. They presented him a new revolver and a pair of handcuffs.

Outgoing officials expressed appreciation of the cooperation of other officials and of the kindness of the public and extended best wishes to their successors.

Cottage Grove Levy For 1928 Taxes 75.8 Mills

The total tax levy for Cottage Grove for 1928, taxes to be paid in 1929, is 75.8 mills. This includes school district, county and state taxes. The special road levy of four mills voted by the people in November for the Florence and McKenzie highways has increased the total tax of every city in the county except Florence. The latter city had special taxes a year ago that gave it a total levy of 103.8.

Every taxing unit has increased its levy slightly.

There was a decrease in both births and deaths in Cottage Grove during 1928, according to the annual report of C. E. Frost, city health officer. There were 107 births and 42 deaths, while in 1927 there were 117 births and 57 deaths. During both years there were a number of births at Eugene hospitals.

The health officer reported that the influenza epidemic is subsiding and that there are no quarantines for contagious diseases. The quarantine has been lifted on two cases of scarlet fever in the Chitwood family at Latham.

Highway Commission Is To Start Siuslaw Road

The state highway commission has definitely committed itself to the Siuslaw-Florence highway by ordering 18 miles of grading on the Rainier-Florence section at an estimated cost of \$600,000, half of the work to be completed this year and half next year. This will be the most difficult and expensive piece of construction on the road. Members of the commission are working with representatives of the Southern Pacific railway on right-of-way agreements.

Years ago the county permitted the railway to take the grade of the road of that time, the railway agreeing to provide a road as good as the one taken. There has never been a satisfactory settlement between the county and railway. At present there is hardly room for both railway and highway and cooperation of the railway will be an important factor in early completion of the highway.

Poultry Cooperative Is Successful

The Pacific Cooperative Poultry Producers of Portland report a prosperous year for the Eggsman, official organ of the organization, says that the sign-up for 1929 will mean more hens under contract than last year, notwithstanding withdrawal from the northern half of Clark county, Washington. At the two-day meeting of the board of directors a six per cent dividend was declared and the surplus has been increased to nearly \$100,000. It may not be generally known that Oregon poultrymen receive an average of six cents a dozen more than the average throughout the country, but such is the United States department's report, and that is said to be the result of marketing Oregon eggs so largely through cooperatives.
