**OREGON'S CONGRESSMEN.**

Every two years during the 18 years that this writer has been editing a newspaper in Oregon someone has explained to him just how the informant was going to defeat do-nothing W. C. Hawley for congress. Every two years this writer has explained to the enthusiastic one why he thought it couldn't be done, even though the one might become a useful and energetic congressman, for some of those who opposed Hawley would have made good congressmen after they had had his experience and after they had been berated as do-nothings.

About 18 years ago westerners became aware of the fact that frequent changing of congressmen had worked a hardship on the west in competing with the east which had long before adopted the policy of keeping congressmen on the job for long terms of years, and Congressman Hawley has remained on the job, steadily working toward the top.

Conservationist rent the camps of his opponents a year ago when Hawley was advanced to the chairmanship of the all-important ways and means committee. What are they going to do now? goes Hawley is given a head of the appropriations committee. While a member of either of those committees seldom is given any other committee work, here Hawley as chairman of the greatest of all, and a member of the next most important committee in congress. He is now not only on the committee that provides for revenue, but also on the committee that does the spending.

Never before has the chairmanship of the ways and means committee been bestowed upon a western congressman, and this second honor gives Oregon an honor never before conferred upon a congressman of any state.

This is going to be bitter medicine for those who would rather the state had not been thus honored than to have seen Hawley the vehicle by which the honor was obtained.

It might be noted that Senator McNary also has kept the state in the limelight in recent years through joint authorship of farm relief bills. As a friend of the president since the two were kids in Marion county, he is in a position to do further great things for state and nation.
