Whereas, the members of the Fraternity Order of Eagles are opposed to any such conduct as might or could bring discredit upon their beloved order, now, therefore,

Be It Resolved, by the members of the Seventeenth Annual Session of the Oregon State Aerie, Fraternity Order of Eagles, in convention assembled, that should any member of this Aerie or any member of the Fraternity Order of Eagles attending this convention so far forget himself as to become intoxicated or otherwise be guilty of misconduct on the streets of this city or in any public place, that such member be immediately expelled from the Oregon State Aerie and his credentials be revoked, and that his home Aerie be notified by the Secretary of the State Aerie of the action taken and the reason therefor.

County May Have Too Many Dog Men

At a recent session of the county board, the dog catchers were called upon to collect \$75 alleged due as wages for the last half of May.

The suit is the consummation of a declaration that he would attempt to foreclose a county lien for the remainder of 1932. The complaint declares that on February 1, 1932, the dog board drew up a contract with him in which was agreed he should be paid \$150 a month and five cents a mile for travel on the 100-mile mark each month. He was discharged May 1, "without reason" the complaint charges.

SCHOOL BUDGET COMES UP FOR VOTE MONDAY

Items Total Nearly \$4,500 Less Than Those of Year Ago.

Consideration of the annual school budget comes up at the annual taxpayers' meeting to be held at 2 o'clock Monday in the high school auditorium. Polls will remain open until 8 o'clock. A clerk is also to be elected. Worth Harvey has served in that position for a number of years and is expected that he will be re-elected.

So far as known there has been no change in the budget to be submitted, which is nearly \$4,500 less than the one submitted a year ago, and this despite a reduction of \$2,500 in anticipated receipts, an increase of \$1,165 in the item for debt service and an increase of \$2,424 in the emergency fund item to care for anticipated tax delinquencies.

A reduction of \$1300 is expected in the amount to come from the county fund, of \$1,000 in the amount to come from the elementary fund, of \$125 in the amount to come from the state fund, of \$700 in the amount to come from the high school fund, of \$700 in state and federal subsidies and of \$25 in sundry receipts.

Decreases in budgeted items have been made as follows: General control, \$271; supervision, \$1,259; high school teachers, \$1,000; grade teachers, \$2,937.50; supplies, \$200; text books, \$165.20; operation, \$451.40; repairs and equipment, \$550; furniture, equipment and municipal assessments, \$145. These reductions total \$8,044.40.

ALFRED WHITE HOME IS BURNED TO GROUND

The Alfred M. White home on the London road, which was the pioneer home of Mr. White's parents, Mr. and Mrs. N. W. White, was burned to the ground Tuesday afternoon. Articles saved included a piano, bedroom furniture, sitting room furniture, clothing, some fruit and some bedding, all from the home of Schaeffer. An ice box containing five bottles of beer and a number of empty bottles was found in Hart's car.

Origin of the flames was not known, but it was believed they must have started from a defective fuse, although there had been fire in any stove for three hours before the fire broke out at 2:30. The Cottage Grove fire department was called and the flames had gained such headway before the department arrived that it was impossible to fight them. TARIFF TO GIVE SOME HOPE TO LUMBERMEN

General Revival Can Not Come Until Conditions Over Country Improve.

(Grow's Lumber Digest.)

During the past two weeks the lumber market in the northwest has become so extremely dead that this status has been accepted philosophically. A great deal of interest was surrounded the protective tariff on lumber. No one is foolish enough to believe that there will be an immediate revival in business when the tariff is taken care of here in the United States given this much needed protection, but that it will eventually show direct benefits is a foregone conclusion.

At the most there is only a limited amount of business developing in the domestic markets today. That the Canadian mills have been getting the lion's share of anything that they were in position to turn out during the past three or four weeks is a known fact. From a cold-blooded standpoint the buyers are not to be blamed for the difference in exchange has alone been enough, with everything else, to warrant buying from British Columbia mills. That some concerns have anticipated the requirements in the scramble to get under cover later is a foregone conclusion. Most of the retailers who get their deliveries by all-rail shipments are only ordering after they have made sales. Their inventory is getting pretty badly mixed and there is no doubt that the Canadian mills even though it has been possible to obtain a small savings. It is predicted that within two weeks after the tariff goes into effect the difference in the demand should be such that there will be no one expecting anything but, this is at least a faint ray of hope in the gloom. There is the first encouragement seen in a long time.

Added to the direct benefits which the lumber industry may receive from having lumber included in the revenue tariff, which is to be the budget, the opinion is widespread that with the government having put its financial house in order, the depression will be at the bottom of the depression and give a starting point for an upward turn in business. During the past few days there has been a new confidence on the part of the buying public. That there are many millions of dollars in the United States which are being hoarded to believe that prices are to go no lower is an opinion shared by the best economists.

The gradual liquidation of inventories which has been taking place throughout the northwest since the first of the year has been much more effective than many realize. There are comparatively few stocks left in the hands of the dealers. An analysis shows an extremely small supply of the standard items of yard stock that are most called for. It has been pointed out in this publication that the stage is being set for giving the manufacturers control of the market. It is a very short time before once become sold on the idea that prices will no longer decline. The attitude of the mills is ready to meet that most of them will not consider any business today that necessitates special saving unless they can get their own prices raised. The market is moving without much argument, prices if specifications fit accumulations on hand.

One thing is certain, conditions cannot get much if any worse than they are and with the mills now reconciled to rest on their own resources there is an improvement in general outlook is better, at least to that extent.

COUNTY FAIR PASSED UP FOR PRESENT YEAR

A two-day 4-H club exhibit will take the place of the county fair this year, according to a decision of the fair board, which has taken this action on account of straightened finances of the county.
